In continuation of the CSIR-NAL & CSIR-4PI notification cited at reference above, it is hereby notified for information of all the concerned that the candidates who have qualified in the typing test are eligible for the next stage i.e. Competitive Written Examination for recruitment to the posts of Junior Secretariat Assistant (Gen./S&P/F&A) of CSIR-NAL & CSIR-4PI. The exam will be scheduled on 15.03.2026 (SUNDAY) at CSIR-NAL, Bengaluru.

A common written Examination will be conducted for the posts of Junior Secretariat Assistant (Gen./S&P/F&A) of CSIR-NAL and CSIR-4PI.

The Scheme of the written examination that has already been given in the Advt. No. 03/2025 & 02/2025.

**Instructions:**

- The candidates qualified for written examination are required to download their admit cards from the link which will be provided at [www.nal.res.in](http://www.nal.res.in) & [www.csir4pi.res.in](http://www.csir4pi.res.in). Link for downloading of admit cards will be active shortly. (For any technical issues regarding downloading admit card, contact help desk through email [recruitnal.nal@csir.res.in](mailto:recruitnal.nal@csir.res.in). Candidates who fail to download the admit card will not be allowed for written examination.
- The admit card will also be sent through email to all the qualified candidates.
- Candidates are required to take print out of the admit card, duly fill the candidate's details and affix a recent self-attested passport photograph. This is required to be submitted at the time of written examination i.e. the reporting time as indicated above.
- For any queries regarding downloading of Admit Cards may be e-mailed to [recruitnal.nal@csir.res.in](mailto:recruitnal.nal@csir.res.in).
- In case of a candidate qualified for more than one post code in JSA (Gen./S&P/F&A), he / she will be issued only one common admit card for the Competitive Written Examination.

- vi. The Candidates are required to produce their Original Admit Card along with any ONE of the following original valid Photo Identity proof:

1. Voter Identity Card	2. Aadhar Card with Photograph	3. Driving License
4. Passport	5. PAN Card	
6. Any other valid ID issued by Central or State Government		

- vii. No Candidates without an Admit Card along with original valid Photo ID proof shall be allowed in the examination hall.
- viii. The seating arrangements of the candidates shall be displayed on the notice board at the entrance of the examination centre.
- ix. If there is any mismatch between the name indicated in the Admit Card and Photo Identity Proof, the candidate will not be allowed to appear for the written examination.
- x. Any request for change of Date / Time / Venue of the Written Examination shall NOT be entertained under any circumstances.
- xi. Candidates must abide by further instructions, if any, which may be given to them by the Invigilator at the time of Written Examination. If any candidate fails to abide by the instructions or indulges in disorderly or improper conduct they will render themselves liable to expulsion from the Written Examination or such other penalty as the Competent Authority, CSIR-NAL may deem fit.
- xii. Only Blue or Black Ball Point pen for marking responses on OMR Answer Sheet is allowed.
- xiii. There will be two papers (Paper-I and Paper-II). The second paper will be evaluated only for those candidates who secure the minimum threshold marks (to be determined by the Selection Committee) in the first paper.
- xiv. Candidates may note that there will be no negative marking in Paper-I. In Paper-II, there will be one negative mark for every wrong answer in the OMR-based objective type multiple-choice examination.
- xv. Candidates are required to maintain discipline and decorum for smooth conduct of the Written Examination.
- xvi. On receipt of question booklet, candidates should ensure that all the pages of the question booklet are intact and not mutilated / torn or damaged. In case of discrepancy the same should be brought to the notice of the invigilator on duty or supervisory staff.
- xvii. On completion of the Written Examination, the Candidates shall remain seated at their seats and wait until the Question Paper Booklets, OMR Sheets and Admit Cards are collected and accounted for.
- xviii. Candidates may ensure that they return the Question Paper Booklets, OMR Sheets and Admit Cards to the Invigilator before they leave the Venue. Candidates failing to return the same shall be disqualified and may be liable to suitable action as per rules.
- xix. No TA/DA shall be paid for attending the Written Examination.
- xx. Candidates are not allowed to bring any type of electronic gadgets like Mobile phone, Calculator, Tabs, Laptops, Bluetooth devices, Smart Watch etc. into the Written Examination Hall except Admit Card & ID Proof.

- xxi. The candidature for this Written Examination is Provisional and is subject to fulfilling the prescribed Criteria of Age, Educational Qualifications and other conditions as specified in the advertisement. This admit card is issued purely on the basis of the details furnished by the candidate in the online application form, which is subject to a detailed scrutiny and if at any stage of recruitment, any discrepancy found or does not fulfil the eligibility criteria, the candidature is liable to be cancelled. Further, if any of these shortcoming(s) is / are detected after appointment in CSIR-NAL and CSIR-4PI, his / her services are liable to be summarily terminated.
- xxii. **The candidates must bring the original documents** along with the admit card to verify the information furnished in the application at the time of appearing for written examination.
- a. 10<sup>th</sup> / SSC Certificate or equivalent Certificate for age proof
  - b. All original educational qualifications (from 10<sup>th</sup> / SSC or equivalent certificate onwards) along with mark sheets
  - c. XII Certificate and Mark sheets
  - d. All original experience certificates, as proof of experience. (if applicable)
  - e. Any other relevant certificates for written examination etc.,
  - f. Latest / valid community or category certificates etc., as per Gol format in case of SC/ST/OBC (NCL)/EWS/PwBD/Women (widows /divorced /judiciary separated)/Ex-Servicemen categories etc., if claimed.
  - g. The qualified candidates belonging to SC/ST/OBC (NCL)/EWS/PwBD/Women (widows/divorced/judiciary separated)/Ex-Servicemen categories etc., their candidature is subject to submission / verification of latest certificates in the prescribed Gol format.
  - h. In case the candidate is employed under Central / State Govt. / Autonomous Body / PSU, a "No Objection Certificate" from the present organization to submit the NOC at the time of examination, if applicable
  - i. Any other original document in support of the claim made in the application, as applicable.
- xxiii. Candidates are required to submit a self-attested copy of the above certificates to the verification team at the time of written examination.
- xxiv. Candidates may please note that mere issue of admit card / attending the competitive written examination does not constitute any right for appointment to the posts for which they applied / offer of employment in CSIR-NAL and CSIR-4PI.
- xxv. The travel and stay arrangements have to be taken care by the candidates themselves. CSIR-NAL & CSIR-4PI will not bear any expenditure in this regard.
- xxvi. Any point not covered specifically in the above instructions, the decision of the Competent Authority, CSIR-NAL & CSIR-4PI, Bengaluru shall be final and binding on all candidates.

### **Guidelines for persons with Benchmark Disabilities:**

1. The instructions for PwBD candidates regarding Competitive Written Examination shall be as per CSIR-NAL Advt. No.03/2025 & CSIR-4PI Advt. No.02/2025 and as per GoI/CSIR guidelines.
2. In case of Persons with benchmark disabilities (PwBD) in the category of Visually impaired (blindness), cerebral palsy, orthopedically handicapped (both arm affected), orthopedically handicapped candidates who has a locomotor disability wherein the dominant writing extremity is affected to the extent of slowing down the performance of the candidate (such deficiency to be indicated in the certificate, issued by competent authority, submitted by the candidate) those candidates are eligible to use a scribe with a compensatory time of 20 minutes for every hour of the examination or as otherwise advised. In case the duration of the examination is less than an hour, then the duration of the compensatory time should be allowed on pro-rata basis.
3. For availing this compensatory time, the candidate should provide original PwBD Certificate from notified Medical Authority as per the detailed advertisement. If the candidate fails to produce the required certificate (in original) on the date of written examination, he/she is not eligible for compensatory time.
4. Guidelines for Persons with Disabilities, including the use of Scribe and the required formats to be produced, are already mentioned in the detailed advertisement.
5. Visually impaired (VI) Candidates are eligible for scribe/passage dictator. The Scribe dictator is identified by the candidates at their own cost and as per their own choice.
6. The candidate shall be responsible for any misconduct on the part of the scribe brought by him during the written examination. Candidate as well as the scribe will have to give a suitable undertaking, in the prescribed format 'Letter of Undertaking for Using Own Scribe as already mentioned in the detailed advertisement.
7. The candidate will have to arrange his/her own scribe at his/her own cost. The qualification of the scribe should be one step below the qualification of the candidate taking the examination.
8. A person acting as a scribe for one candidate cannot be a scribe for another candidate.
9. The scribe may be from any academic stream.
10. The candidates with benchmark disabilities (PwBD) allowed for own scribe shall be required to submit the details of the own scribe, before the examination as per Annexures, as applicable and submit the originals on the day of examination. In addition, the scribe has to produce a valid ID proof in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with relevant Annexures mentioned above. If subsequently it is found that the qualification of the scribe is not as declared by the candidate, then the candidate shall forfeit his right to the post and claims relating thereto.
11. Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfil any laid down eligibility criteria or suppressed material facts the candidature of the applicant will stand cancelled irrespective of the results of the written examination.

12. During the exam, at any stage, if it is found that scribe is independently answering the questions, the exam session will be terminated and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test administrator personnel that the scribe independently answered the questions.
13. One eyed candidates and partially blind candidates who are able to read the normal Question Paper set with or without magnifying glass and who wish to write/indicate the answer with the help of magnifying glass will be allowed to use the same in the Examination Hall and will not be entitled to a Scribe. Such candidates will have to bring their own magnifying glass to the Examination Hall.
14. Visually Impaired candidates (who suffer from not less than 40% of disability) may opt to view the contents of the test in magnified font and all such candidates will be eligible for compensatory time of 20 minutes for every hour.

## DECLARATION

2. As per the rules, the candidate availing services of a scribe is eligible for compensatory time of 20 minutes for every hour of the examination.
3. In view of the importance of the time element and the examination being of a competitive nature, the candidate undertakes to fully satisfy the Medical Officer of the Organization that there was necessity for use of a scribe as his/her writing speed is affected by the disabilities.
4. In view of the fact that multiple appearance / attendance in the examination are not permitted, the candidate undertakes that he/she has not appeared / attended the examination more than once and that the scribe arranged by him/her is not a candidate for the examination. Also, the same scribe cannot be used by more than one candidate. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled.
5. We hereby declare that all the above statements made by us are true and correct to the best of our knowledge and belief.

We also understand that in case it is detected at any stage of recruitment that we do not fulfill the eligibility norms and/or that the information furnished by us is incorrect/false or that we have suppressed any material fact(s), the candidature of the applicant will stand cancelled, irrespective of the result of the examination.
