The Selection of the candidates are subject to the following:

1. The above position is purely temporary on Contract basis. Candidate engaged in this position will not have any right implicit or explicit for consideration for regularization / absorption against any CSIR-NAL post(s)
2. Termination of Service: The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 30 days. In case, a part time medical officer desires to leave the contract/job, he/she has to serve the notice period of one month which can be curtailed/extended at the discretion of the Competent Authority
3. The date for determining age/qualification and experience shall be the date of the walk in interview
4. **Confidentiality of data, information and documents:** The information, data and documents related to the patients shall remain confidential. No one shall utilize or publish or disclose to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for the office, without the express written consent of

the office. The Part Time Medical Officer is bound to hand over the entire set of records to the office before the expiry of the contract.

5. **Conflict of Interest:** The Part Time Medical Officer engaged by this office, shall not represent or give opinion or advice to others in any matter which is averse to the interest of these offices.
6. The engagement of Part Time Medical Officer is subject to the terms and conditions issued by CSIR-NAL/CSIR-4PI in this regard from time to time. For all intent and purposes, the services of part time medical officer will be under administrative control of the Director, CSIR-NAL/ CSIR-4PI.
7. The decision of the Director, CSIR-NAL/CSIR-4PI in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates.
