NOTICE INVITING E-TENDER FOR ELECTRICAL WORKS

Sr. Controller of Administration invites the sealed item rate online tender (E-tender) on behalf of The Director, CSIR-NAL for the work of **Retrofitting of existing 750 KVA DG set with New Diesel Engine, reconditioning of existing alternator and Installation, Testing and Commissioning of entire newly retrofitted DG Set at CSIR-NAL Kodihalli, Bengaluru – 560017** from approved & eligible vendors / contractors & who have worked with CSIR or its Laboratories / institutes, CPWD, Railways, MES, State / Central Govt. / Semi Govt. organizations / Public Sector undertaking / Govt. Autonomous bodies / KPTCL / BESCO and all ESCOMS. The eligible bidder who having the Class - I electrical license or equivalent certificate issued by Chief Electrical Inspectorate authorities, Govt. of Karnataka / Govt. of India / any other state Govt. authorities to work on electrical installation **or** OEM / OEA of DG set manufacturers, proof of registration with GST, ESI & EPF authorities and satisfactory **work completion certificate for at least three similar works each of value not less than 40% or two similar works each of value not less than 60% or one similar work of value not less than 80 % of estimated cost** as shown in the NIT during the last seven (7) years ending last day of the month previous to the one in which tenders are invited. The contractor / vendor / bidder fulfilling the above conditions may download the tender document through <https://etenders.gov.in/eprocure/app>.

Explanation for Similar works: The work having categorized as specialized in nature, the composite category vendor / contractor is also eligible provided they fulfill prescribed eligibility criteria of the NIT and it is subject to:

1. Supply, installation, testing & commissioning of DG set of capacity not less than 600 KVA DG set and as associated electrification works in Government / Semi Government / Public sector organizations.

Or

2. OEM / OEA of approved make may associate with the electrical contractor / other agency who fulfill the prescribed eligibility criteria in the NIT for execution of the work with necessary affidavit to confirm their association.

Or

3. The electrical contractor / vendor who fulfill the prescribed eligibility criteria in the NIT may associate with approved make OEM for procurement of specialized equipment (DG sets related items) and gets its installation from OEM / Authorized agency/ Service Provider and written commitment with regards to supply, delivery schedule as per requirement, satisfactory installation & commissioning, unconditional technical support

throughout execution of contract as well as comprehensive maintenance contract for the useful life of system. Also letter of commitment from OEM to provide required spares for healthy functioning of equipment at least for a period of 7 (Seven) years from the date of commissioning & acceptance of the system. The necessary affidavit by the electrical contractor / vendor to be produced showing their association along with the tender. (Spicemen copy attached)

Note: The successful tenderer is allowed to change their association with OEM/OEA/contractor during execution subject to fulfilling prescribed eligibility criteria specified in the tender document with the approval of competent authority.

The estimated cost of work put in the tender will be based on prevailing market rates & CPWD DSR 2022.
