8. Government of India's Public Procurement Policies are binding in CSIR-NAL, as the case may be. Therefore, the Bidders are requested to refer to the instruction/guidelines as and when issued regarding Government of India Procurement Policies for Make in India and MSE issued by Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DPIIT) and Ministry of Finance. The onus for ensuring compliance to the provisions of the Policy notifications keeping in view the requirements under this Tender document entirely rests with the Bidder.

Although provisions related to Government's public procurement purchase preference policy are briefly stated in the tender document under relevant clauses, any bidder seeking exemptions / benefits / preferences under MSEs / Start Up India / Make in India / DPIIT, Ministry of Commerce and Industry policy or any other policy / scheme of the Government of India, which is currently in force MUST at the time of bidding itself declare its bidding status and the benefit/preference sought under the relevant policy of the Government and enclose all related documents / certificates etc. for claiming such benefits. The bidder must also clearly highlight the provisions of the policy with respect to the benefit/preference being sought by it for which it meets the eligibility conditions. Any exemption of DPIIT Order of at the discretion of the Competent Authority of CSIR.

IF THE BIDDER FAILS TO DECLARE ITS STATUS AND/ OR FAILS TO CLAIM THE POLCIY BENEFIT/ PREFERENCE/ EXEMPTION ETC. AND/ OR FAIL TO SUBMIT NECESSARY DOCUMENTS/ CERTIFICATES IN SUPPORT OF ITS CLAIM AT THE TIME OF BIDDING ITSELF, ITS CLAIM SHALL NOT BE ENTERTAINED AT A LATER STAGE IN THE BIDDING PROCESS AND NO OPPORTUNITY SHALL BE PROVIDED TO IT TO SUBMIT ANY DOCUMENT/ CERTIFICATE IN SUPPORT OF ITS CLAIM AS IT VIOLATES THE TENDERING PROCESS.

- 9. (a) In case of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/ dealer. There can be only one bid from the following:
  - i) The Principal manufacturer directly or through one Indian agent on his behalf; and
  - ii) Indian/foreign agent on behalf of only one principal.
  - (b) Foreign Bidders must disclose the name and address of agent and representative in India and Indian bidder must disclose their foreign principal or associates.
  - (c) If bidder is Indian Agent of Foreign Principal, the following instruction shall be complied and as amended from time to time as on the date of issue of Tender:
    - i) Bidder must necessarily comply with conditions of "Make in India" Order No. F-45021/2/2017-PP (BE-II) dated 16-Sep-2020 of Ministry of Commerce and Industry, Government of India, as amended from time to time on the date of issue of Tender.
    - ii) The Bidder shall comply with restrictions under Rule 144(xi) of the GFR 2017 related to restrictions on participation of Foreign Bidders and their Authorised Indian Agent/Dealer in terms of Order No.P-45021/112/2020-PP(BE-II) (E-43780) dated 24-Aug-2020 of the Ministry of Commerce and Industry, Department for Promotion of Industry and Internal Trade, as amended from time to time as on the date of issue of Order.
- 10. The bids of those bidders failing to comply the following clauses will be summarily rejected.
  - (a) The bidders proposing to supply finished products directly/indirectly from Bidders of Countries sharing the land border with India should submit copy of registration done with the Ministry of Home Affairs and Ministry of External Affairs.
  - (b) If the products supplied are not from Bidders of Countries sharing Land border with India, the Bidders should enclose a declaration
  - (c) The debarment of a Bidder/Vendor in this tender, if any, is reciprocal of that Principal's Country, if it is Import.
- 11. The Director, CSIR-National Aerospace Laboratories (NAL), Bengaluru, India reserves the right to accept or reject any bids or accept all tenders either in part or in full or to split the order, or to annul the bidding process without assigning any reasons there for.

#### <u>A</u> <u>Introduction</u>

Instructions to bidder are broad guidelines to be followed while formulating the bid and its submission to the Purchaser. It also describes the methodology for opening and evaluation of bids and consequent award of contract. Instructions applicable for Import of Goods (Global Tender Enquiry) need not be applicable for Domestic Tender Enquiry and those may be ignored.

## 1.1. Eligible Bidders

- 1.1.1 This Invitation for Bids is open to all suppliers. However, only Class-I and Class-II local suppliers are eligible to participate in **Domestic Tender**. Any bidder from foreign country can participate in **Global Tender Enquiry** subject to clause 1.1.3 below. Mode of procurement is whether Domestic Tender or Global Tender Enquiry is specified in NIT.
- 1.1.2 Bidders should not be associated, or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods to be purchased under this Invitation of Bids.
- 1.1.3 Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods or services, only if the bidder is registered with the Competent Authority as specified in Ministry of Finance (GoI) Order No.6/18/2019 PPD dated 23rd July 2020 and as amended from time to time.
- 1.1.4. Bidders who fulfil the Eligibility Criteria mentioned in Chapter 6 will be considered for Technical Evaluation of bids.
- 1.1.5 The bidders who have been temporarily suspended or removed from the list of registered suppliers by the purchaser or banned from Ministry/country wide procurement **shall be ineligible** for participation in the bidding process.

## 1.2 Cost of Bidding

1.2.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and "the Purchaser", will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

## 1.3 <u>Code of Integrity</u>

1.3.1 The bidders/suppliers should sign a declaration about abiding by the Code of Integrity for Public Procurement and submit it in the form as per **Chapter-8: Annexure-H** along with bid documents. In case of any transgression of this code, the bidder is not only liable to be removed from the list of registered suppliers, but it would be liable for other punitive actions such as cancellation of contracts, banning and blacklisting or action by Competition Commission of India, and so on.

#### 1.3.2 Code of integrity for Public Procurement:

The Purchaser requires that the bidders, suppliers, contractors and consultants should observe the highest standard of ethics and should not indulge in the following prohibited practices, either directly or indirectly, at any stage during the procurement process or during execution of resultant contracts:

i)	"Corrupt practice"	making offers, solicitation or acceptance of bribe, rewards or gifts or any material benefit, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process or contract execution;
ii)	"Fraudulent practice"	any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. This includes making false declaration or providing false information for participation in a tender process or to secure a contract or in execution of the contract;

iii)	"anti-competitive practice"	any collusion, bid rigging or anti-competitive arrangement, or any other practice coming under the purview of the Competition Act, 2002, between two or more bidders, with or without the knowledge of the purchaser, that may impair the transparency, fairness and the progress of the procurement process or to establish bid prices at artificial, non-competitive levels;
iv)	"coercive practice"	harming or threatening to harm, persons or their property to influence their participation in the procurement process or affect the execution of a contract;
v)	"conflict of interest":	participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of purchaser who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the purchaser with an intent to gain unfair advantage in the procurement process or for personal gain; and
vi)	"Obstructive practice"	materially impede the purchaser's investigation into allegations of one or more of the above mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing of evidence material to the investigation; or by making false statements to investigators and/or by threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or by impeding the purchaser's Entity's rights of audit or access to information;
vii)	Collusive practice	means a scheme or arrangement between two or more bidders, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive levels.

1.3.2 The Purchaser will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question.

## 1.3.3 Obligations for Proactive disclosures

i)	The Purchaser as well as bidders, suppliers, contractors and consultants, are obliged
	under Code of Integrity for Public Procurement to sue-moto proactively declare any
	conflicts of interest (coming under the definition mentioned above - pre-existing or as
	and as soon as these arise at any stage) in any procurement process or execution of
	contract. Failure to do so would amount to violation of this code of integrity; and
ii)	The bidder must declare, whether asked or not in a bid document, any previous
	transgressions of such a code of integrity with any entity in any country during the last
	three years or of being debarred by any other Procuring Entity. Failure to do so would
	amount to violation of this code of integrity;

To encourage voluntary disclosures, such declarations would not mean automatic disqualification for the bidder making such declarations. The declared conflict of interest would be evaluated and mitigation steps, if possible, taken by the purchaser.

## 1.3.4 Punitive Provisions

Without prejudice to and in addition to the rights of the Purchaser to other penal provisions as per the bid documents or contract, if the Purchaser comes to a conclusion that a (prospective) bidder/supplier, directly or through an agent, has violated this code of integrity in competing for the contract or in executing a contract, the purchaser may take appropriate measures including one or more of the following:

i) If bids are under consideration in any procurement:		ids are under consideration in any procurement:

		c)	Rejection and exclusion of the bidder from the procurement process.

1.5.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.

## 1.6 Clarification of tender documents

#### PRE-BID CONFERENCE (PBC)

The objective of PBC is to provide a platform for clarifying issues and clearing doubt, if any, about the specification and other allied technical/commercial details of the bid document. This is also an opportunity to question the bidding conditions and the bidding process. You can bring to our notice any restrictive terms, condition, inconsistent/conflicting, clauses terms/information or item specification in the tender document so that required changes can be made, if any.

#### 1.6.1 In case when there is NO PRE-BID CONFERENCE

A prospective Bidder requiring any clarification of the bidding Documents shall contact the Purchaser in writing through the CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a> OR at the Purchaser's address specified in the Special Conditions of Contract (SCC). The Purchaser will respond in writing through the CPP Portal OR through e-mail to any request for clarification, provided that such request is received not later than ten (10) days prior to the due date for submission of bids. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB Clause 1.7 relating to amendment of bidding documents and ITB Clause 1.20 relating to Due date for Submission of Bids. The amendments issued would be hosted on the CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a> of the purchaser for the benefit of the prospective bidders who are expected to take cognizance of the same before formulating and submitting their bids.

#### 1.6.2. In case when there is PRE-BID CONFERENCE

- a) A prospective Bidder requiring any clarification of the Biding Documents shall contact the Purchaser in writing through CPPP website https://etenders.gov.in OR at the Purchaser's address specified in the Special Conditions of Contract (SCC), latest by the date specified in the Invitation for Bids / NIT which would be deliberated as per ITB Clause 1.6.2 (b) of Instructions to the Bidders. No request for clarification or query shall be normally entertained after the Pre-Bid Conference. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB Clause 1.7 relating to amendment of Bidding Documents and ITB Clause 1.20 relating to Due Date for Submission of Bids. The clarifications and amendments issued would also be hosted on the CPPP website https://etenders.gov.in of the Purchaser for the benefit of the other prospective bidders.
- A Pre-bid Conference shall be held at venue and schedule specified in Tender Detail Screen. All prospective bidders are requested to kindly attend the Pre-bid Conference. In order to facilitate CSIR-NAL for proper conduct of the Pre-bid Conference, all prospective bidders are requested to kindly submit their queries (with envelope bearing Tender No. and Date on top and marked "Queries for Pre-bid Conference") so as to reach CSIR-NAL as indicated in Invitation to Bid. Queries may be sent by email to CSIR-NAL shall answer the queries during the pre-bid conference, which would become a part of the proceedings of the Pre-bid Conference. These proceedings will become a part of clarifications / amendments to the bidding documents and would become binding on all the prospective bidders. These proceedings would also be hosted on CPPP website https://etenders.gov.in for the benefit of all the prospective bidders. Before formulating and submitting their bids, all prospective bidders are advised to surf through the CPPP website https://etenders.gov.in after the Pre-bid Conference, in order to enable them take cognizance of the changes made in the Tender document.

A Pre-bid Conference shall be held as indicated in invitation to bid, if any. All prospective bidders are requested to kindly attend the Pre-bid Conference. In order to facilitate the purchaser, the proper conduct of the Pre-bid Conference, all prospective Bidder requiring any clarification of the Bidding Documents shall contact the Purchaser in writing at the Purchaser's address specified in the NIT/Special Conditions of Contract (SCC), latest by the date specified in the critical date sheet. No request for clarification or query shall normally be entertained after the deadline/pre-bid conference if any. The purchaser shall answer the queries during the pre-bid conference, which would become a part of the proceedings of the Pre-bid Conference. The proceeding of the Pre-Bid Conference would be hosted on the website of the purchaser/CPP Portal. Before formulating and submitting their bids, all prospective bidders are advised to surf through the purchaser's website/CPP Portal after the Pre-bid Conference, in order to enable them take cognizance of the revised tender conditions.

1.6.3 The queries, clarifications and amendments issued would also be hosted on the website of the CPP Portal/Purchaser for the benefit of the other prospective bidders and also shall be sent to all bidders who have purchased the tender documents.

#### 1.7 Amendment of Tender Documents

- 1.7.1 At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the tender documents by amendment. The same would also be hosted on the website of the CPP Portal/Purchaser and all prospective bidders are expected to surf the website before submitting their bids to take cognizance of the amendments.
- 1.7.2 All prospective bidders who have down loaded the Tender Document should surf website of CPP Portal/Purchaser from time to time to know about the changes / modifications in the Tender Document. The changes / modifications would also be hosted on the website of CPP Portal/Purchaser. All prospective bidders are expected to surf the website of CPP Portal/Purchaser before formulating and submitting their bids to take cognizance of the amendments.
- 1.7.3 In order to allow prospective bidders' reasonable time in which to take the amendment into account in preparing their bids, the Purchaser, at its discretion, may extend the deadline for the submission of bids and host the changes on the website of **CPP Portal/Purchaser.**

#### C. PREPARATION OF BIDS

#### 1.8. Language of Bid

- 1.8.1 The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Purchaser shall be written in English language only especially when the details are technical. However, if GOI makes it mandatory under Raj Bhasha Abhiyan, in that case view of Rajbhasha unit of CSIR may be sought.
- 1.8.2 The Bidder/Supplier shall bear all costs of translation, if any, to the English language and bear all risks of the accuracy of such translation, for documents provided by the Bidder/Supplier.

#### 1.9 Purchase Preference Policies

- 1.9.1 The purchaser intends to give product reservation/purchase preference/price preference in line with current Govt. of India procurement policies to help inclusive national economic growth by providing long term support to Small and Medium enterprises (SMEs) and disadvantaged sections of the society and to address environmental concerns along with preferential market access in govt. procurements.
- 1.9.2 For the above purpose, local supplier means a supplier or service provider whose product or service offered for procurement meets the minimum local content as prescribed in DIPP Order No.P-45021/2/2017-PP (BE-II) dated 28<sup>th</sup>May, 2018 or by the Ministries/Departments in pursuance of this order, as amended from time and time and local content means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

## 1.10.1 <u>Documents comprising the E-bid</u>

The E-bid shall comprise of the documents as per the requirement of the Tender Document. The documents specified in Chapter-8, Annexure-M, Deviation Statement Form (Part-II) should be scanned and **uploaded in PDF format in proper sequence**. ## 1.10.2 <u>Documents comprising Single Bid</u>

All the documents (as applicable) specified in Chapter-8: Annexure-M (Part-II) should be submitted in Single E-Bid along with BOQ- Price bid.

## 1.10.3 <u>Documents comprising Two Bid (Technical Bid & Price Bid)</u>

Technical bid should comprise documents (as applicable) specified in Chapter-8:Annexure-M (Part-II). Price Bid should comprise of BOQ & Annexure-J (if applicable).

## 1.10.4 Bill of Quantity (BOQ)- Price bid

Bidders should necessarily submit their price bid in the format provided and no other format is acceptable. The prices mentioned in BOQ shall be considered for evaluation and comparison of bids. Bidders are required to download the BOQ file, open it and complete the Blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

## 1.11. Bid form and price schedule

1.11.1 The bidder shall complete the Bid Form and the appropriate price schedule form furnished in the

bidding documents. These forms must be completed without any alterations to its format and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested. The Bid Form and the appropriate Price Schedule form shall be submitted in accordance with **ITB Clause 1.18.3** of the bidding documents.

## 1.12. Bid Prices

1.12.1 The Bidder shall fill up the Bill of Quantity (BoQ) which is Price Bid. The BoQ should be filled up carefully as it will be used for evaluation of L1. The contract will be awarded to L1 bidder subject to fulfillment of other terms and conditions of tender and also the Price Preference Policy of Government of India, as amended from time and time and as specified in the tender document

1.12.2 Prices indicated on the price-schedule form shall be entered separately in the following manner:

- 1.12.3 The terms FOB, FCA, CIF, CIP etc. shall be governed by the rules prescribed in the current edition of the Incoterms published by the International Chambers of Commerce, Paris.
- 1.12.4 Where there is no mention of packing, forwarding, freight, insurance charges, taxes etc. such offer shall be rejected as incomplete.
- 1.12.5 The price quoted shall remain fixed during the contract period and shall not vary on any account
- 1.12.6 All lots and items must be listed in Unpriced bid and priced separately as per BoQ/Price Schedule. If the Unpriced bid shows items listed but not priced in BoQ/Price Schedule, their prices shall be assumed to be included in the prices of other items. Lots or items not listed in the Price Schedule shall be assumed to be not included in the bid.
- 1.12.7 (a) In case of imports the freight & insurance will be paid by the Purchaser, as the consignments are to be shipped through the Purchaser nominated freight forwarder.
  - (b) Custom Duty is levied on all import meant for CSIR-NAL. Hence, the suppliers are requested to quote only on FOB/FCA basis, freight, insurance and custom duty as applicable to R&D Institutions will be paid by the Purchaser.
- 1.12.8. In case of INR bids the price criteria should be on Free Delivery to CSIR-NAL. Govt. Levies like GST etc., if any, shall be paid at actual rates applicable on the date of delivery. Rates should be quoted accordingly giving the basic price, GST etc., if any.
- 1.12.9 (a) CSIR-NAL is a Public Funded Research Institute under Department of Scientific & Industrial Research, Government of India and concessional Custom duty @ 5.15% is applicable for the goods purchased for Research purpose vide Government of India vide Notification No.51/96–Customs dated 23-July-1996, as amended from time to time.
  - (b) CSIR-NAL is a Public Funded Research Institute under Department of Scientific & Industrial Research, Government of India and concessional GST is applicable for the Goods purchased for Research purpose vide Ministry of Finance (Department of Revenue) vide Notification No.

- 47/2017-Integrated Tax (Rate) dated 14-Nov-2017 and Notification No.45/2017-Central Tax and Notification No.45/2017-State-Tax(Rate) dated 14<sup>th</sup> November, 2017, as amended from time to time.
- (c) The Certificates is issued without any commitment by CSIR-NAL. Hence, the supplier should ensure its applicability for their own interest.
- 1.12.10 Please state specifically in your offer whether the duties and taxes are extra over the prices quoted, failing which it will be presumed that the prices are inclusive of taxes and duties and no claim would be entertained for statutory variations at a later date.
- 1.12.11 Stipulations like "GST is presently not applicable but the same will be charged if it becomes leviable later on" is not acceptable unless in such cases it is clearly stated that GST will not be charged if the same becomes applicable later on due to increase in turn over etc. If a bidder fails to comply with this requirement, his quoted price shall be loaded with the quantum of duty which is normally applicable on the item in question for the purpose of comparison with the prices of other tenderers.
- 1.12.12 a) All payments due under the contract shall be paid after deduction of statutory levies (at source) (like TDS, IT, TCS etc.) wherever applicable. In this connection GOI notification may be referred to before submitting quote on their own interest. Statutory deductions will be done accordingly at the time of payment.
  - b) If the supplier have not filed Income Tax Returns for the latest FY, TDS/TCS is applicable as per Income Tax Act.
  - c) Withholding Taxes are applicable on Foreign payments such as but not limited to Royalty, Fees for Technical Services etc..

## 1.13. Bid Currencies

1.13.1 Prices shall be quoted in Indian Rupees for offers received for supply within India and in freely convertible foreign currency in case of offers received for supply from foreign countries i.e. domestic tenderers are to quote and accept their payment in Indian currency; Indian agents of foreign suppliers are to receive their agency commission in Indian currency; cost of imported goods & services rendered in India, which are directly imported against the contract, may be quoted in foreign currency (currencies). Multicurrency BoQ shall have provision to quote prices in multiple currencies including Indian Rupees.

## 1.14. <u>Documents Establishing Bidder's Eligibility and qualifications</u>

- 1.14.1 The bidder shall furnish, as part of its bid, documents establishing the bidders' eligibility to bid and its qualification (as specified in Chapter-6) to perform the contract if its bid is accepted.
- 1.14.2 The documentary evidence of the bidder's qualification to perform the contract if the bid is accepted shall establish to the purchaser's satisfaction that;

(a)	The bidder meets the qualification criteria listed in bidding documents if any.
(b)	Bidder who doesn't manufacture the goods it offers to supply shall submit Manufacturers' Authorization Form (MAF) using the form specified in the bidding
	document to demonstrate that it has been duly authorized by the manufacturer of the

(c)	In case a bidder not doing business within India, it shall furnish the certificate to the effect that the bidder is or will be represented by an agent in India equipped and able to carry out the supply, maintenance, repair obligations etc. during the warranty and post
	warranty period or ensure a mechanism at place for carrying out the supply, maintenance, repair obligations etc. during the warranty and post-warranty period.

1.14.3 Conditional tenders/offers shall not be accepted. Alternate offers/makes/models will not be considered.

## 1.15 <u>Documents Establishing Goods' Eligibility and Conformity to Bidding Documents</u>

1.15.1 To establish the goods' eligibility, the documentary evidence of the goods and services eligibility shall consist of a statement on the country of origin of the goods and services offered which shall be confirmed by a certificate of origin at the time of shipment.

- 1.15.2 To establish the conformity of the goods and services to the specifications and schedule of requirements of the bidding document, the documentary evidence of conformity of the goods and services to the bidding documents may be in the form of literature, drawings and data, and shall consist of:
  - (a) A detailed description of the essential technical and performance characteristics of the goods;
  - (b) A list giving full particulars, including available sources and current prices, of spare parts, special tools, etc., necessary for the proper and continuing functioning of the goods during the warranty period following commencement of the use of the goods by the Purchaser in the Priced-bid; and
  - (c) An item-by-item commentary on the Purchaser's Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications or a statement of deviations and exceptions to the provisions of the Technical Specifications.
- 1.15.3 For purposes of the commentary to be furnished pursuant to above, the Bidder shall note that standards for workmanship, material and equipment, designated by the Purchaser in its Technical Specifications are intended to be descriptive only and not restrictive. The Bidder may substitute these in its bid, provided that it demonstrates to the Purchaser's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.
- 1.16. Bid Security (BS) / Earnest Money Deposit (EMD)
- 1.16.1 The Bidder shall furnish, as part of its bid, a bid security (BS) / Earnest Money Deposit (EMD) for an amount as specified in the Invitation for Bids in the form of Bank Guarantee / Demand Draft drawn on any Nationalized/ Scheduled bank in favour of the "Director, National Aerospace Laboratories, Bengaluru", as the case may be.

A. In the case of foreign bidder(s):

a)	The BS /EMD shall be submitted either by the principal or by the Indian agent.
b)	The bidder who submits the tender on behalf of their principals should produce
	documentary evidence in support of their authority to quote.
c)	The Bank Guarantee (BG) is insisted due to steep fluctuations in foreign exchange

## B. In the case of Indigenous Bidder(s):-

The BS/EMD shall be submitted by the manufacturer or their specifically authorized dealer/bidder.

- 1.16.2 E-bids submitted without BS/EMD will stand rejected. BS/EMD will not be accepted in the form of Cash/Cheque or any other form other than DD/Bank Guarantee as per format given in Chapter-8, as the case may be. No Interest is payable on BS/EMD.
- 1.16.3 The bid security is required to protect the Purchaser against the risk of Bidder's conduct, which would warrant the security's forfeiture.
- 1.16.4 The bid security shall be in Indian Rupees for offers received for supply within India and denominated in the currency of the bid or in any freely convertible foreign exchange in the case of offers received for supplies from foreign countries in equivalent Indian Rupees. The bid security shall be in one of the following forms at the bidders' option:
  - (a) A Bank guarantee (BG) or stand-by Letter of Credit issued by a Nationalized/Scheduled bank /Foreign Bank operating in India in the form provided in the bidding documents and valid for 45 days beyond the Validity of the Bid. In case a Bidder desires to submit a BG from the Foreign Bank, then the same should be confirmed by a Nationalised/Scheduled Indian Bank [OR]
     (b) A Banker's cheque or Account Payee demand draft in favour of the purchaser issued by any Nationalized/ Scheduled bank [OR]

A Fixed Deposit Receipt pledged in favour of the Director, CSIR-NAL, Bengaluru.

1.16.4 The bid security shall be payable promptly upon written demand by the purchaser in case the conditions listed in the **ITB clause 1.16.11** are invoked.

1.16.5 The bid security should be submitted in its original form to the address mentioned below:-

Scanned Copy of Demand Draft/Bank Guarantee towards bid security should be uploaded along with the E-bid. The envelope enclosing EMD should be superscribed with Tender Number and specifying as "EMD" on the envelop.

1.16.6 Bidders that are currently registered with the purchaser or registered as MSEs will continue to remain registered during the tender validity period also and are exempted from payment of EMD. In case the tenderer falls in these categories, the bidder should furnish a certified copy of its valid registration details. Except for MSEs, this exemption is valid for the trade group and monetary value of registration only. The MSEs are provided tender document free of cost and are exempted from the payment of Bid Security provided the goods are produced and the services are rendered by them and not for any trading activities undertaken by them. Further firms who are having Udyog Aadhar Memorandum are entitled to all benefits available for MSEs under the Public Procurement Policies for MSEs and can get registered with any of the following agencies:

District Industries Centre Khadi and Village Industries Commission (b) Khadi and Village Industries Board (c) (d) Coir Board National Small Industries Corporation (e) Directorate of Handicraft and handloom and (f) Any other body specified by the Ministry of MSME (g) UdyogAadhaar Acknowledgement/UgyogAadhaar Memorandum (h) MoMSME

- 1.16.7 The bid security of unsuccessful bidder will be discharged /returned as promptly as possible positively within a period of 30 days after the expiration of the period of bid validity or placement of order whichever is later, without any interest.
- 1.16.8 The successful Bidder's bid security will be discharged upon the Bidder furnishing the performance security, without any interest. Alternatively, the BS/EMD could also be adjusted against Performance Security, if it is paid through Demand Draft / Banker's Cheque.
- 1.16.9 Where any aggregator has been appointed by the Ministry of MSME, themselves quote on behalf of some MSE units, such offers will be considered as offer from MSE units and all such facilities would be extended to these aggregators also.
- 1.16.10 The receipt of Bid Security before time and date of submission of bid is mandatory requirement.

  The bid is liable to be rejected if the Bid Security is not received within the stipulated time.
- 1.16.11 The bid security may be forfeited:
  - (a) If a Bidder withdraws or amends or modifies or impairs or derogates its bid during the period of bid validity specified by the Bidder on the Bid Form; or
     (b) In case of a successful Bidder, if the Bidder fails to furnish order acceptance within 14 days of the order or fails to sign the contract and/or fails to furnish Performance Security within 21 days from the date of contract/ order.
- **1.16.12** Whenever the bidder chooses to submit the Bid Security in the form of Bank Guarantee, then the Bidder should advise the banker issuing the Bank Guarantee to immediately send by Registered Post (A.D.) an unstamped duplicate copy of the Guarantee directly to the Purchaser with a covering letter to compare with the original BG for the correctness, genuineness, etc.
- 1.16.13 The bidder who seek exemption for EMD/BS or when **EMD/BS specified in NIT is NIL**, then Bidder should submit Bid securing Declaration as per Format specified in Chapter-8.

## 1.17. Period of Validity of Bids

1.17.1 Bids shall remain valid for minimum of 90 days after the date of bid opening prescribed by the Purchaser. A bid valid for a shorter period shall be rejected by the Purchaser as non-responsive.

- 1.17.2 In exceptional circumstances, the Purchaser may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing (by post, fax or e-mail). The bid security provided shall also be suitably extended failing which the bid would be summarily ignored. A Bidder may refuse the request without forfeiting its bid security. A Bidder granting the request will not be required nor permitted to modify its bid.
- 1.17.3 Bid evaluation will be based on the bid prices without taking into consideration the above corrections.

## 1.18. Format and Signing of Bid

- 1.18.1 The bids may be submitted as Single-bid or Two-bid as specified in the Invitation for Bids / NIT.
- 1.18.2 In case the bids are invited on single bid basis, then the Bidder shall submit E-bid comprising all documents listed under ITB clause 1.10.1 relating to documents comprising the bid.
- 1.18.3 In case the bids are invited on two-bid system, the Bidder shall submit E-bid in two separate parts. First part shall contain Technical bid comprising all documents listed under clause relating to Documents Comprising the Bid. The second part shall contain the Price-Bid as per the BoQ.
- 1.18.4 The scanned copies of the E-bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to the Contract. All pages of the bid, except for un-amended printed literature, shall be initialed by the person or persons signing the bid detailing his/her name and contact details.
- 1.18.5 Any interlineations, erasures or overwriting shall be valid only if they are initialed by the persons or persons signing the bid.

## D. Submission and sealing of E-Bids

## 1.19. Submission, Sealing and Marking of Bids

- 1.19.1 Bids shall be submitted online only at CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a>
  (Bids received by Manual/ Offline bids/ FAX/E-mail shall not be accepted under any circumstances.)
- 1.19.2 The Bidder shall download the Tender Enquiry Document directly from the website <a href="https://etenders.gov.in">https://etenders.gov.in</a> and shall not tamper/modify it in any manner. In case if the same is found to be tampered/modified in any manner, Tender/Bid will be summarily rejected and EMD would be forfeited.
- 1.19.3 The complete bidding process is online. Bidders should be in possession of valid Digital Signature Certificate (DSC) of class III for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above. If the envelope is not digitally signed & encrypted the Purchaser shall not accept such open Bids for evaluation purpose and shall be treated as non-responsive and rejected.
- 1.19.4 Bidders are advised to go through "Bidder Manual Kit", "System Settings" & "FAQ" links available on the login page of the e-Tender portal for guidelines, procedures & system requirements. In case of any technical difficulty, Bidders may contact the help desk numbers & email ids mentioned at the e-tender portal. Every Bidder will be required to obtain a Class-III Digital Signature (DSC) for submission of Bids.
- 1.19.5 Bidders are advised to visit CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a> regularly to keep themselves updated, for any changes/modifications in the Tender Enquiry Document.
- 1.19.6 Intending bidders are advised to visit CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a> regularly till closing date of submission of bid, for any corrigendum.
- 1.19.7 The Bid Security/Earnest Money Deposit shall be deposited through Bank Guarantee / Demand Draft drawn in favour of "The Director, National Aerospace Laboratories, Bengaluru". The original Bid Security/EMD must be delivered at address mentioned in Sr.No.2 of NIT till bid submission date and time as mentioned in "Date Sheet" failing which the bid shall be summarily rejected.

1.19.8 Purchaser shall receive the bids online through CPPP portal only. The e-Tender portal shall automatically stop accepting bids after the scheduled date and time specified in the Tender Document. Partially submitted bids shall be treated as invalid and shall not be processed.

#### 1.20. Due date for Submission of Bids

- 1.20.1 EMD/BS must be received by the Purchase at the address specified in NIT not later than the time and date specified in NIT.
- 1.20.2 Bidders are advised to upload and submit their E-bids timely within due date for submission of E-Bids in view of the electronic process so as to avoid last minute issues.
- 1.20.2 The Purchaser may, at its discretion, extend the deadline for submission of bids by amending the bid documents in accordance with Clause relating to Amendment of Bidding Documents in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline will thereafter be subject to the due date as extended.

## 1.21. <u>Late Submission of EMD / BS</u>

- 1.21.1 Any Bid Security/EMD received by the Purchaser after the due date for submission of bids prescribed by the Purchaser is liable to be rejected.
- 1.21.2 Bidders must note that the e-tender portal shall not permit uploading of bids after the scheduled time of submission.

## 1.22 Withdrawal, substitution and Modification of Bids

- 1.22.1 The bidder may withdraw, correct or modify his digitally signed bid after submission prior to the deadline for submission of bids, through provisions of e-tendering portal.
- 1.22.2 The bidder is not allowed to modify or withdraw bid after deadline for submission of bids.

#### E. Opening and Evaluation of E-Bids

#### 1.23 Opening of E-Bids by the Purchaser

- 1.23.1 The E-bids shall be opened online by authorised officials of the Purchaser as per schedule given in Date Sheet. In case of two bid tender, the Price bid of only those bidders who qualified in technical evaluation, shall be opened.
- 1.23.2 In the event of the specified date of Bid opening being declared a holiday for the Purchaser, the Bids shall be opened at the appointed time and location on the next working day. In two-part bidding, the financial bid shall be opened only after technical evaluation. No separate intimation shall be sent to the bidders in this regard.
- 1.23.3 Since, E-bid is an online process; the E-bid opening or any other process may be delayed due to any technical/server issue. If any such issue arises, this will not be tantamount to process delay and CSIR-NAL will not be responsible for the same.
- 1.23.4 On opening of bids online, accepting the bid will not mean that the firm is technically or financially qualified.
- 1.23.5 Bids will be opened online on the specified date and time. There is no need to visit purchaser's premises to attend bid opening. If the bids cannot be opened on due date/ time due to any technical or administrative issues (network/connectivity issues, holidays, office closure etc.) these will be opened as soon as the issue is resolved or next working day as the case maybe. Bids submitted online on CPPP portal are safe, secure, and confidential and can be seen only after opening following the due process

#### 1.24. Confidentiality

1.24.1 Information relating to the examination, evaluation, comparison, and post qualification of bids, and recommendation of contract award, shall not be disclosed to bidders or any other persons not officially concerned with such process until publication of the Contract Award.

However, decisions taken during process of tender evaluation shall be hosted on e-Tenders portal.

1.24.2 Any effort by a Bidder to influence the Purchaser in the examination, evaluation, comparison, and post qualification of the bids or contract award decisions may result in the rejection of its Bid.

## 1.25. Clarification of Bids

1.25.1 To assist in the examination, evaluation, comparison and post qualification of the bids, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing and no change in prices or substance of the bid shall be sought, offered or permitted. However, no negotiation shall be held except with the lowest bidder, at the discretion of the purchaser. Any clarification submitted by a bidder in respect to its bid which is not in response to a request by the purchaser shall not be considered.

## 1.26. <u>Preliminary Examination</u>

- 1.26.1 The Purchaser shall examine the bids to confirm that all documents and technical documentation requested in ITB Clause 1.10.1 have been provided, and to determine the completeness of each document submitted.
- 1.26.2 The Purchaser shall confirm that the following documents and information have been provided in the Bid. If any of these documents or information is missing, the offer shall be rejected.

## 1.27 <u>Bidder's right to question rejection.</u>

1.27.1 A Bidder shall have the right to be heard in case Bidder feels that a proper procurement process is not being followed and/or tender has been rejected wrongly. Only a directly affected bidder can represent in this regard as under:

i)	Only a bidder who has participated in the concerned procurement process i.e. pre- qualification, bidder registration or bidding, as the case may be, can make such representation;		
ii)	In case pre-qualification bid has been evaluated before the bidding of Technical bids, an application for review in relation to the technical bid may be filed only by a bidder who has qualified in pre-qualification bid;		
iii)	In case technical bid has been evaluated before the opening of the financial bid, an application for review in relation to the financial bid may be filed only by a bidder whose technical bid is found to be acceptable.		
iv)	Following decisions of the purchaser in accordance with the provision of internal guidelines shall not be subject to review:		
	a) Determination of the need for procurement;		
	b)	Selection of the mode of procurement or bidding system;	
	c)	Choice of selection procedure;	
	d)	Provisions limiting participation of bidders in the procurement process;	
	e) The decision to enter into negotiations with the L1 bidder;		
	f)	Cancellation of the procurement process except where it is intended to subsequently	

	re-tender the same requirements;

g)	Issues related to ambiguity in contract terms may not be taken up after a contract
	has been signed, all such issues should be highlighted before consummation of the

h)	Complaints against specifications except under the premise that they are either

1.27.2 In case a Bidder feels aggrieved by the decision of the purchaser, the Bidder may then send their representation in writing to the Purchaser's address as indicated in Special Conditions of Contract (SCC) within 05 working days from the date of communication of the purchaser intimating the rejection for reconsideration of the decision by the purchaser.

#### 1.28 Responsiveness of Bids

- 1.28.1 Prior to the detailed evaluation, the purchaser will determine the substantial responsiveness of each bid to the bidding documents. For purposes of this clause, a substantive responsive bid is one, which conforms to all terms and condition of the bidding documents without material deviations, reservations or omissions. A material deviation, reservation or omission is one that:
  - (a) Affects in any substantial way the scope, quality, or performance of the Goods and Related Services specified in the Contract; or
  - (b) Limits in any substantial way, inconsistent with the Bidding Documents, the Purchaser's rights or the Bidder's obligations under the Contract; or
  - (c) If rectified, would unfairly affect the competitive position of other bidders presenting substantially responsive bids.
- 1.28.2 The purchasers' determination of a bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence.
- 1.28.3 If a bid is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the Bidder by correction of the material deviation, reservation or omission.
- 1.28.4 If a bidder quotes Nil Charges/consideration, the bid shall be treated as unresponsive and will not be considered.

#### 1.29 <u>Non-Conformity, Error and Omission</u>

- 1.29.1 Provided that a Bid is substantially responsive, the Purchaser may waive any nonconformities or omissions in the Bid that do not constitute a material deviation.
- 1.29.2 Provided that a bid is substantially responsive, the Purchaser may request that the Bidder submit the necessary information or documentation, within a reasonable period of time, to rectify nonmaterial nonconformities or omissions in the bid related to documentation requirements. Such omission shall not be related to any aspect of the price of the Bid. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
- 1.29.3 Provided that the Bid is substantially responsive, the Bid shall be evaluated as per BoQ.
- 1.29.4 Provided that a bid is substantially responsive, the purchaser may request that a bidder may confirm the correctness of arithmetic errors as done by the purchaser within a target date. In case, no reply is received then the bid submitted shall be ignored and its Bid Security may be forfeited.

## 1.30 <u>Examination of Terms & Conditions, Technical Evaluation</u>

- 1.30.1 The Purchaser shall examine the Bid to confirm that all terms and conditions specified in the GCC and the SCC have been accepted by the Bidder without any material deviation or reservation.
- 1.30.2 The Purchase shall examine the Bid to confirm that Eligibility and Qualification criteria as specified is fulfilled by the Bidder.
- 1.30.3 The Purchaser shall evaluate the technical aspects of the Bid submitted in accordance with **ITB Clause 1.15**, to confirm that all requirements specified in Schedule of Requirements of the Bidding Documents have been met without any material deviation or reservation.
- 1.30.4 If, after the examination of the terms and conditions and the technical evaluation, the Purchaser

determines that the Bid is not substantially responsive in accordance with ITB Clause 1.28, it shall reject the Bid.

1.30.5 Any bidder seeking benefit/preference under MSME / Make in India or any other policy/scheme of the Government of India, which is currently in force MUST at the time of bidding itself enclose all relevant documents / certificates etc. for claiming such benefits. The bidder must also clearly highlight the provisions of the policy and the kind of benefit being sought by it for which it meets the conditions for claiming such benefits. It may be noted that no other benefit / preference /concessions which is beyond the scope of the policy or the bidder's entitlement under the policy shall be given / considered by us. If the bidder fails to claim such benefit and/or fail to submit necessary documents/certificates in support of its claim at the time of bidding itself, its claim shall not be entertained at a later stage in the bidding process and no opportunity shall be provided to it to submit any document / certificate.

## 1.31 Conversion to Single Currency

1.31.1 To facilitate evaluation and comparison, the Purchaser will convert all quoted prices expressed in various currencies in which the bid prices are payable to Indian Rupees at the selling exchange rate established by any bank in India as notified in the Newspapers on the date of bid opening in the case of single bid and the rates prevalent on the date of opening of the Technical Bids in case of two-bid. For this purpose, "Bill Currency Selling" exchange rate notified in www.xe.com or www.rbi.org or any other website could also be used by the purchaser.

### 1.32 Evaluation and comparison of bids

- 1.32.1 The Purchaser shall evaluate each bid that has been determined, up to this stage of the evaluation, to be substantially responsive.
- 1.32.2 To evaluate a Bid, the Purchaser shall only use all the factors, methodologies and criteria defined below. No other criteria or methodology shall be permitted.
- 1.32.3 Price Preference
- **1.32.3.1** Price preference to Local suppliers as per Make in India procurement policy of Govt of India Reference: DPIIT Order No. P-45021/2/2017-PP (BE-II) dated 16<sup>th</sup> September 2020issued by inistry of Commerce (Govt of India), as amended from time to time on the date of issue of order.

Only Class-I and Class-II local suppliers are eligible to bid for all procurements other than Global Tender Enquiry and Purchase preference shall be given as specified below:

1) Definitions of terms applicable to Make in India procurement policy of Govt of India

'Local content' means the amount of value added in India which shall be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the
, , , , , , , , , , , , , , , , , , , ,
total value, in percent.
'Class-I Local supplier' means a supplier provider whose product offered for
procurement meets the local content of 50% and above.
'Class-II Local supplier' means a supplier provider whose product offered for
procurement meets the local content of 20% and above but less than 50%.
'Non-Local supplier' means a supplier provider whose product offered for
procurement meets the local content of less than 20%.
'L1' means the lowest tender or lowest bid or the lowest quotation received in this
tender, bidding process or other procurement solicitation as adjudged in the
evaluation process as per the tender or other procurement solicitation .
'Margin of purchase preference ' means the maximum extent to which the price
quoted by a local supplier may be above the L1 for the purpose of purchase
preference.

2) Tendered goods are **divisible** in nature, the following procedure shall be followed to evaluate L1 bidder and bidder for award of contract **with** the **margin of purchase preference of 20%** to Class-I Local supplier:

a)	Among all qualified bids, the lowest bid will be termed as L1. If L1 is from a Class-I
	local supplier, the contract for full quantity will be awarded to L1.
b)	If L1 bid is not from a Class-I local supplier, 50% of the order quantity shall be

awarded to L1. Thereafter, the lowest bidder among the Class-I local suppliers, will be invited to match the L1 price for the remaining 50% quantity subject to the local supplier's quoted price falling with in the margin of purchase preference, and contract for that quantity shall be awarded to such Class-I local supplier subject to matching the L1 price. In case such lowest eligible Class-I local supplier fails to match the L1 price or accepts less than the offered quantity, the next higher Class-I local supplier within the margin of purchase preference shall be invited to match the L1 price for remaining quantity and so on, and contract shall be awarded accordingly. In case some quantity is still left uncovered on local suppliers, then such balance quantity may also be ordered on the L1 bidder.

3) Tendered goods are not divisible in nature, the following procedure shall be followed to evaluate L1 bidder and bidder for award of contract with the margin of purchase preference of 20% to Class-I Local supplier:

a)	Among all qualified bids, the lowest bid will be termed as L1. If L1 is from a Class-l
	local supplier, the contract will be awarded to L1.
b)	If L1 is not from a Class-I local supplier, the lowest bidder among the Class-I local suppliers, will be invited to match the L1 price subject to local supplier's quoted price falling within the margin of purchase preference, and the contract shall be awarded to such Class-I local supplier subject to matching the L1 price.
c)	In case such lowest eligible Class-I local supplier fails to match the L1 price, the Class-I local supplier with the next higher bid within the margin of purchase preference shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the Class-I local suppliers within the margin of purchase preference matches the L1 price, then the contract may be awarded to the L1 bidder.
d)	Only Class-II Local suppliers are not eligible to get price preference under this clause.

#### Applicability in tenders where contract is to be awarded to multiple bidders

In tenders where contract is awarded to multiple bidders subject to matching of L1 rates or otherwise, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:

- a. In case there is sufficient local capacity and competition for the item to be procured, as notified by the nodal Ministry, only Class I local suppliers shall be eligible to bid. As such, the multiple suppliers, who would be awarded the contract, should be all and only 'Class I Local suppliers'.
- b. In other cases, 'Class II local suppliers' and 'Non local suppliers' may also participate in the bidding process along with 'Class I Local suppliers'.
- c. If 'Class I Local suppliers' qualify for award of contract for at least 50% of the tendered quantity in any tender, the contract may be awarded to all the qualified bidders as per award criteria stipulated in the bid documents. However, in case 'Class I Local suppliers' do not qualify for award of contract for at least 50% of the tendered quantity, purchase preference shall be given to the 'Class I local supplier' over 'Class II local suppliers'/ 'Non local suppliers' provided that their quoted rate falls within 20% margin of purchase preference of the highest quoted bidder considered for award of contract so as to ensure that the 'Class I Local suppliers' taken in totality are considered for award of contract for at least 50% of the tendered quantity.
- d. First purchase preference shall be given to the lowest quoting 'Class-I local supplier', whose quoted rates fall within 20% margin of purchase preference, subject to its meeting the prescribed criteria for award of contract as also the constraint of maximum quantity that can be sourced from any single supplier. If the lowest quoting 'Class-I local supplier', does not qualify for purchase preference because of aforesaid constraints or does not accept the offered quantity, an opportunity may be given to next higher 'Class-I local supplier', falling within 20% margin of purchase preference, and so on.

#### 1.32.3.2 Price Preference to MSMEs

- 1) In case MSME bidder is L1 entire value of the tender is to be ordered on the L1 MSME bidder.
- 2) In tender, participating Micro and Small Enterprises quoting price within price band of L1 + 15% shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprise and such Micro and Small Enterprise shall be allowed to supply upto 25 percent of the total tendered value (where the tender quantity can be split).
- 3) In case of more than one such MSMEs are in the price band of L1 + 15% and matches the L1 price, the supply may be shared proportionately if the goods can be split.
- 4) In case the tendered quantity of goods cannot be split, MSME shall be allowed to supply total tendered quantity provided their quoted price is within a price band of L1 + 15% and they match the L1 price.
- 5) If the quantity cannot be split and there are more than one eligible MSME bidders (price band within L1+15%) then the opportunity to match the L1 rate of the tender shall be given first to MSME (who have quoted lowest rate among the MSMEs within the price band of L1+15%) and the total quantity shall be awarded to him after matching the L1 price of the tender.
- 6) If the MSME who have quoted lowest rate among the MSMEs in the price band of L1 + 15% do not agree to match the rate of L1 of the tender, then the next ranked MSME bidder who has quoted within the price band of L1 + 15% in order shall be given chance to match the rate of L1 for award of the quantity/order.

1.32.5 The comparison between the indigenous and the foreign offers shall be made on FOR destination basis and CIF/CIP basis respectively. However, the CIF/CIP prices quoted by any foreign bidder shall be loaded further as under:

(a) Towards customs duty and other statutory levies – as per applicable rates.

- (b) Towards custom clearance, inland transportation etc. 2% of the CIF/CIP value.
- 1.32.6 In case of Purchase of many items against one tender, which are not inter-dependent or where compatibility is not a problem, normally the comparison would be made on Ex-Works, (in case of Indigenous items) and on FOB/FCA (in case of Imports) prices quoted by the firms for identifying the lowest quoting firm for each item.
- 1.32.7 Orders for imported Goods need not necessarily be on FOB/FCA basis rather it can be on the basis of any of the incoterm latest edition as may be amended from time to time by the ICC or any other designated authority and favourable to the purchaser
- 1.32.8 Wherever the price quoted on FOB/FCA and CIF/CIP basis are the same, the Contract would be made on CIF/CIP basis only.
- 1.32.9 The GCC and the SCC shall specify the mode of transport i.e., whether by Air/Sea/Road/Rail.
- 1.32.10 There is <u>no provision to purchase optional items</u>. The specifications embodied in the tender documents would be the basis of evaluating the responsiveness of bids received.
- 1.32.11 The Purchaser shall compare all substantially responsive bids to determine the lowest valuated bid, in accordance with ITB Clause 1.32.
- 1.32.12 Where there is no mention of packing, forwarding, freight, insurance charges, taxes etc. such offers shall be rejected as incomplete.

## 1.33 Contacting the Purchaser

- 1.33.1 Subject to ITB Clause 1.25, no Bidder shall contact the Purchaser on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded.
- 1.33.2 Any effort by a Bidder to influence the Purchaser in its decisions on bid evaluation, bid comparison or contract award may result in rejection of the Bidder's bid.

## 1.34 Post qualification

- 1.34.1 In the absence of pre-qualification, the Purchaser will determine to its satisfaction whether the Bidder that is selected as having submitted the lowest evaluated responsive bid is qualified to perform the contract satisfactorily, in accordance with the criteria listed in **ITB Clause 1.15.**
- 1.34.2 The determination will take into account the eligibility criteria listed in the bidding documents and will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, as well as such other information as the Purchaser deems necessary and appropriate.
- 1.34.3 An affirmative determination will be a prerequisite for award of the contract to the Bidder. A negative determination will result in rejection of the Bidder's bid.

## F. AWARD OF CONTRACT

## 1.35 Negotiations

1.35.1 Normally, there shall not be any negotiation. Negotiations, if at all, shall be an exception and only in the case of items with limited source of supply. Negotiations shall be held with the lowest evaluated responsive bidder. Counter offers tantamount to negotiations and shall be treated at par with negotiations.

## 1.36 <u>Award Criteria</u>

1.36.1 Subject to ITB Clause 1.39, the Purchaser will award the contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined to be the lowest evaluated bid, provided further that the Bidder is determined to be qualified to perform the contract satisfactorily. The details of the award would be hosted on the website of the Purchaser and CPPP website <a href="https://etenders.gov.in">https://etenders.gov.in</a>.

## 1.37 Purchaser's right to vary Quantities at Time of Award

1.37.1 The Purchaser reserves the right at the time of Contract award to increase or decrease the quantity of goods and services originally specified in the Schedule of Requirements to the extent of 25% without any change in unit price or other terms and conditions of the Purchase Order.

## 1.38 Option Clause

1.38.1 The Purchaser reserves the right to increase or decrease the quantity of the required goods up to 25% (Twenty-Five) per cent at any time, till final delivery date (or the extended delivery date of the contract), by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of the delivery period (or the extended delivery period)

#### 1.39 Purchaser's right to accept Any Bid and to reject any or All Bids

1.39.1 The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders.

#### 1.40 Notification of Award

- 1.40.1 **Prior to the expiration of the period of bid validity**, the Purchaser will notify the successful bidder in writing by registered letter or by cable or telex or fax or e mail that the bid has been accepted and a separate purchase order shall follow through post.
- 1.40.2 Until a formal contract is prepared and executed, the notification of award should constitute a binding contract.
- 1.40.3 Upon the successful Bidder's **furnishing of the signed Contract Form** and performance security pursuant to **ITB Clause 1.43**, the Purchaser will promptly notify each unsuccessful Bidder and will discharge its bid security.

#### 1.41 Signing of Contract

- 1.41.1 Promptly after notification, the Purchaser shall send the successful Bidder the Agreement/Purchase Order.
- 1.41.2 Within twenty-one (21) days of date of the Purchase Order, the successful Bidder shall sign, date, and return it to the Purchaser.

## 1.42 Order Acceptance

- 1.42.1 The successful bidder should submit Order acceptance within 14 days from the date of issue of order/signing of contract, failing which it shall be presumed that the Bidder is not interested and the bid security is liable to be forfeited pursuant to ITB Clause 1.16.11.
- 1.42.2 The order confirmation must be received within 14 days. However, the Purchaser has the powers to extend the time frame for submission of order confirmation beyond the original date. Even after extension of time, if the order confirmation is not received, the contract is liable to be cancelled provided that the purchaser, on being satisfied that it is not a case of cartelization and the integrity of the procurement process has been maintained, may, for cogent reasons, offer the next successful bidder an opportunity to match the financial bid of the first successful bidder, and if the offer is accepted, award the contract to the next successful bidder at the price bid of the first successful bidder.

#### 1.43 Performance Security

1.43.1 Within 21 days of receipt of the notification of award/Purchase Order as per **GCC Clause 2.12**, the supplier shall furnish Performance Security for the amount specified in SCC, valid for the time 60 days beyond the fulfillment of all contractual obligations including warranty.

#### 1.44 Integrity Pact

1.45.1 Integrity Pact binds both buyers and sellers to ethical conduct and transparency in all activities from pre-selection of bidders, bidding and contracting, implementation, completion and operation related to the contract.

- 1.45.2 The Integrity pact essentially envisages an agreement between the prospective vendors/bidders and the buyer, committing the persons/officials of both sides, not to resort to any corrupt practices in any aspect/stage of the contract. Only those vendors/bidders, who commit themselves to such a Pact with the buyer, would be considered competent to participate in the bidding process. In other words, entering into this Pact would be a preliminary qualification. The essential ingredients of the Pact include:
  - Promise on the part of the Purchaser to treat all bidders with equity and reason and not to seek or accept any benefit, which is not legally available; Promise on the part of bidders not to offer any benefit to the employees of the Purchaser (ii) not available legally and also not to commit any offence under Prevention of Corruption Act, 1988 or Indian Penal Code 1860; Promise on the part of bidders not to enter into any undisclosed agreement or (iii) understanding with other bidders with respect to prices, specifications, certifications, subsidiary contracts; etc. Undertaking (as part of Fall Clause) by the bidders that they have not and will not sell the (iv) same material/equipment at prices lower than the bid price; (v) Foreign bidders to disclose the name and address of agents and representatives in India and Indian Bidders to disclose their foreign principals or associates; (vi) Bidders to disclose the payments to be made by them to agents/brokers or any other intermediary; Bidders to disclose any past transgressions committed over the specified period with any (vii)

other company in India or Abroad that may impinge on the anti-corruption principle;

- 1.45.3 Each page of such Integrity pact proforma would be duly signed by Purchaser's competent signatory. All pages of the Integrity Pact are to be returned by the bidder (along with the technical bid) duly signed by the same signatory who signed the bid, i.e. who is duly authorized to sign the bid and to make binding commitments on behalf of his company. Any bid not accompanied by Integrity Pact duly signed by the bidder shall be considered to be a non-responsive bid and shall be rejected straightway.
- 1.45.4 The SCC shall specify whether there is a need to enter into a separate Integrity pact or not.

Integrity Pact lays down the punitive actions for any violation.

- 1.45.5 The Integrity Pact would be effective from the date of invitation of bids till complete execution of the contract.
- 1.45.6 The names and contact details of the Independent External Monitors (IEM) on the event of the need of IP is as detailed in the SCC.
- 1.45.7 The modal format of IP is at Chapter-7.
- 1.45.8 As a first option, dispute resolution is available through panel of IEMs' apart from arbitration clause. However, the fees / exemptions on the said account shall be equally shared by the parties.

## 1.46 <u>Assistance to Bidders:</u>

(viii)

- 1.46.1 Any queries relating to the Tender Enquiry Document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the NIT.
- 1.46.2 Any queries relating to the process of online bid submission or queries relating to CPP Portal in general may be directed to the 24x7 CPP Portal Helpdesk.

## **GENERAL CONDITIONS OF CONTRACT (GCC)**

## 2.1 <u>Definitions</u>

2.1.1 The following words and expressions shall have the meanings hereby assigned to them:

(a)	Contract	The Contract Agreement entered into between the Purchaser and the Supplier, together with the Contract Documents referred to therein, including all attachments, appendices, and all documents incorporated by reference therein.
(b)	Contract Documents	The documents listed in the Contract Agreement, including any amendments thereto.
(c)	Contract Price	The price payable to the Bidder as specified in the Contract Agreement, subject to such additions and adjustments thereto or deductions there from, as may be made pursuant to the Contract.
(d)	Day	Calendar day
(e)	Completion	The fulfilment of the Related Services by the Supplier in accordance with the terms and conditions set forth in the Contract.
(f)	GCC	The General Conditions of Contract.
(g)	Goods	All of the commodities, raw material, machinery and equipment, and/or other materials that the Supplier is required to supply to the Purchaser under the Contract
(h)	Services	The services incidental to the supply of the goods, such as transportation, insurance, installation, training and initial maintenance and other such obligations of the Supplier under the Contract.
(i)	SCC	The Special Conditions of Contract.
(j)	Subcontractor	Any natural person, private or government entity, or a combination of the above, to which any part of the Goods to be supplied or execution of any part of the Related Services is subcontracted by the Supplier.
(k)	Bidder	The natural Person, Private or Government entity, or a combination of the above, whose bid to perform the Contract has been accepted by the Purchaser and is named as such in the Contract Agreement.
(1)	Council	The Council of Scientific & Industrial Research (CSIR), registered under the Societies Registration Act, 1860 of the Government of India having its registered office at 2, Rafi Marg, New Delhi-110001, India.
(m)	Purchaser	Any of the constituent Laboratory/Institute of the Council situated at any designated place in India as specified in SCC
(n)	The final destination	The place named in the SCC.

## 2.2 <u>Contract Documents</u>

- 2.2.1 Subject to the order of precedence set forth in the Contract Agreement, all documents forming the Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory. The Contract Agreement shall be read as a whole.
- 2.2.2 Successful bidder shall have to enter into Contract Agreement as per Contract Agreement as per Contract Form given in Chapter-7 within 14 days of Placement of Purchase Order having above Rs.10 Lakh or equivalent amount in Foreign Currency.

## 2.3 <u>Fraud, Corruption and Code of Integrity</u>

- **2.3.1** The Purchase requires that Bidders, suppliers, contractors and consultant, if any, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy,
  - (a) The terms set forth below are defined as follows:

I	Corrupt practice	The offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the procurement process or in contract execution
II	Fraudulent practice	A misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract

IV	Coercive practice	Harming or threatening to harm, directly or indirectly, persons

2.3.2 Without prejudice to and in addition to the rights of the Purchaser to other penal provisions as per the bid documents or contract, if the Purchaser comes to a conclusion that a (prospective) bidder/supplier, directly or through an agent, has violated this code of integrity in competing for the contract or in executing a contract, the Purchaser may take appropriate measures including one or more of the following:

a)	Cancellation of the relevant contract and recovery of compensation for loss incurred by
	the purchaser;

- b) Forfeiture or encashment of any other security or bond relating to the procurement;
- c) Recovery of payments including advance payments, if any, made by the Purchaser along with interest thereon at the prevailing rate.
- d) Provisions in addition to above:
  - 1) Removal from the list of registered suppliers and banning/debarment of the bidder from participation in future procurements of the purchaser for a period not less than one year;
  - 2) In case of anti-competitive practices, information for further processing may be filed under a signature of the Joint Secretary level officer, with the Competition Commission of India:
  - 3) Initiation of suitable disciplinary or criminal proceedings against any individual or staff found responsible

## 2.4 <u>Joint Venture, Consortium or Association</u>

2.4.1 If the Supplier is a joint venture, consortium, or association, all of the parties shall be jointly and severally liable to the Purchaser for the fulfilment of the provisions of the Contract and shall designate one party to act as a leader with authority to bind the joint venture, consortium, or association. The composition or the constitution of the joint venture, consortium, or association shall not be altered without the prior consent of the Purchaser.

## 2.5 Scope of Supply

2.5.1 Scope of Supply (i.e. the Goods and Related Services to be performed) shall be as specified in Chapter 4 i.e. Specifications and allied technical details.

#### 2.6 Suppliers' Responsibilities

2.6.1 The Supplier shall supply all the Goods and Related Services included in the Scope of Supply-Clause 2.5 of the GCC and the Delivery and Completion Schedule, as per GCC Clause relating to delivery and document.

## 2.6.2 <u>Amalgamation/Acquisition etc.</u>:

In the event the Manufacturer/Supplier proposes for amalgamation, acquisition or sale its business to any firm during the contract period, the Buyer/Successor of the Principal Company are liable for execution of the contract and also fulfilment of contractual obligations i.e. supply, installation, commissioning, warranty, maintenance/replacement of spares accessories etc. You may confirm this condition while submitting the bid.

#### 2.7 <u>Contract price</u>

2.7.1 Prices charged by the Supplier for the Goods supplied and the Related Services performed under the Contract shall not vary from the prices quoted by the Supplier in its bid.

#### 2.8 Copy Right and Patent Indemnity

#### 2.8.1 Copy Right

The copyright in all drawings, documents, and other materials containing data and information furnished to the Purchaser by the Supplier herein shall remain vested in the Supplier, or, if they

are furnished to the Purchaser directly or through the Supplier by any third party, including suppliers of materials, the copyright in such materials shall remain vested in such third party.

## 2.8.2 Patent Indemnity

a) The Supplier shall, subject to the Purchaser's compliance with GCC Sub-Clause 2.12.2 Indemnify and hold harmless the Purchaser and its employees and officers from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of any nature, including attorney's fees and expenses, which the Purchaser may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright, or other intellectual property right registered or otherwise existing at the date of the Contract by reason of:

(a)	the installation of the Goods by the Supplier or the use of the Goods in India; and
(b)	the sale in any country of the products produced by the Goods

b) If any proceedings are brought or any claim is made against the Purchaser, the Purchaser shall promptly give the Supplier a notice thereof, and the Supplier may at its own expense and in the Purchaser's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.

#### 2.9 Application

2.9.1 These General Conditions shall apply to the extent that they are not superseded by provisions in other parts of the Contract.

## 2.10 Standards

2.10.1 The Goods supplied and services rendered under this Contract shall conform to the standards mentioned in the Technical Specifications, and, when no applicable standard is mentioned, to the authoritative standard appropriate to the Goods' country of origin and such standards shall be the latest issued by the concerned institution.

## 2.11 <u>Use of Contract Documents and Information</u>

- 2.11.1 The Supplier shall not, without the Purchaser's prior written consent, disclose the Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample or information furnished by or on behalf of the Purchaser in connection therewith, to any person other than a person employed by the Supplier in performance of the Contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far, as may be necessary for purposes of such performance.
- 2.11.2 The Supplier shall not, without the Purchaser's prior written consent, make use of any document or information enumerated above except for purposes of performing the Contract.
- 2.11.3 Any document, other than the Contract itself, enumerated above shall remain the property of the Purchaser and shall be returned (in all copies) to the Purchaser on completion of the Supplier's performance under the Contract if so required by the Purchaser.

## 2.12 Performance Security

- 2.12.1 Within 21 days of receipt of the notification of award of Contract/Purchase Order, the Supplier shall furnish performance security in the amount specified in SCC, valid till 60 days after the warranty period. Alternatively, the PS may also be submitted at the time of release of final payment in cases where part payment is made against delivery & part on installation. The PS, where applicable, shall be submitted in advance for orders where full payment is to be made on Letter of Credit (LC) or on delivery. In this case, submission of PS at the time of negotiation of documents through Bank would be stipulated as a condition in the LC and the BS should be kept valid till such time the PS is submitted.
- 2.12.2 The proceeds of the performance security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.
- 2.12.3 The Performance Security shall be denominated in Indian Rupees for the offers received for supplies within India and denominated in the currency of the contract in the case of offers

received for supply from foreign countries or in equivalent Indian Rupees in case the Performance Security is submitted by the Indian Agent.

- 2.12.4 In the case of imports, the PS may be submitted either by the principal or by the Indian agent and, in the case of purchases from indigenous sources, the PS may be submitted by either the manufacturer or their authorized dealer/bidder.
- 2.12.5 The Performance security shall be in one of the following forms:

- 2.12.6 The performance security will be discharged by the Purchaser and returned to the Supplier not later than 60 days following the date of completion of the Supplier's performance obligations, including any warranty obligations, unless specified otherwise in SCC, without levy of any interest.
- 2.12.7 In the event of any contract amendment, the supplier shall, within 21 days of receipt of such amendment, furnish the amendment to the performance security, rendering the same valid for the duration of the contract, as amended for further period of 60 days thereafter.
- 2.12.8 The order confirmation must be received within 14 days. However, the Purchaser has the powers to extend the time frame for submission of order confirmation and submission of Performance Security (PS). Even after extension of time, if the order confirmation /PS are not received, the contract shall be cancelled provided that the purchaser, on being satisfied that it is not a case of cartelization and the integrity of the procurement process has been maintained, may, for cogent reasons, offer the next successful bidder an opportunity to match the financial bid of the first successful bidder, and if the offer is accepted, award the contract to the next successful bidder at the price bid of the first successful bidder.
- 2.12.9 Whenever, the bidder chooses to submit the Performance Security in the form of Bank Guarantee, then Bidder should advise the banker issuing the Bank Guarantee to immediately send by Registered Post (A.D.) an unstamped duplicate copy of the Guarantee directly to the Purchaser with a covering letter to compare with the original BG for the correctness, genuineness, etc.
- 2.13 Installation, Commissioning, Demonstration, <u>Inspections, Tests and Training.</u>
- 2.13.1 The inspections & test, training required would be as detailed in Chapter-4 of the Bidding Document relating to Specification and Allied Technical details.
- 2.13.2 The Bidder shall be responsible for Installation, Commissioning, Demonstration, Inspection, Tests and Training wherever applicable and for after sales service during the warranty and thereafter as specified in Chapter-4

#### 2.14 Packing

- 2.14.1 The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods' final destination and the absence of heavy handling facilities at all points in transit.
- 2.14.2 The packing, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be provided for in the Contract including additional requirements are as given below or /and as specified in SCC and in any subsequent instructions ordered by the Purchaser:

The marking and documentation within and outside the packages shall be:

(a) Each package should have a packing list within it detailing the part No(s), description, quantity etc.

- (b) Outside each package, the contract No., the name and address of the purchaser and the final destination should be indicated on all sides and top.
   (c) Each package should be marked as 1/x, 2/x, 3/x.....x/x, where "x" is the total No. of packages contained in the consignment
   All the sides and top of each package should carry an Appropriate indication/ label/
- (d) stickers indicating the precautions to be taken while handling/storage.

## 2.15 <u>Delivery and Documents</u>

2.15.1 Delivery of the Goods and completion and related services shall be made by the supplier in accordance with the terms specified by the Purchaser in the contract. The details of shipping and/or other documents are given below or/and to be furnished by the supplier are specified in SCC.

- 2.15.2 The terms FOB, FCA, CIF, CIP, etc. shall be governed by the rules prescribed in the current edition of the Inco terms published by the International Chambers of Commerce(ICC), Paris.
- 2.15.3 The mode of transportation shall be as specified in SCC.

## 2.15.4 High-sea sales delivery-term is not acceptable.

- 2.15.5 The Bidders may please note that the delivery of the Goods should be strictly within Delivery Schedule mentioned in the Chapter-4/Purchase Order
- 2.15.6 Goods should not be dispatched until the Bidder/Supplier received a firm Purchase Order.

#### 2.16 Insurance

- 2.16.1 Indigenous goods, the Goods supplied under the Contract shall be fully insured in Indian Rupees against any loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in SCC.
- 2.16.2 Import Goods, the purchaser elect to buy on CIF/CIP basis, the Goods supplied under the Contract shall be fully insured against any loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in SCC.
- 2.16.3 Where delivery of the goods is required by the purchaser on CIF/ CIP basis for Imported Goods or FOR destination for Indigenous Goods, the supplier shall arrange and pay for Marine / Transit Insurance, naming the purchaser as beneficiary and initiate & pursue claims till settlement, on the event of any loss or damage.
- 2.16.4 The equipment to be supplied will be insured by the supplier against all risks of loss or damagefrom the date of shipment till such time it is delivered at CSIR-NAL site in case of Rupee transaction.
- 2.16.5 Where delivery is on FOB or FCA basis for Imported Goods or FOR dispatch Station for Indigenous Goods, the Insurance would be the responsibility of the purchaser.
- 2.16.6 With a view to ensure that claims on insurance companies, if any, are lodged in time, the bidders and /or the Indian agent shall be responsible for follow up with their principals for ascertaining the dispatch details and informing the same to the Purchaser and he shall also liaise with the Purchaser to ascertain the arrival of the consignment after clearance so that immediately thereafter in his presence the consignment could be opened and the insurance claim be lodged, if required, without any loss of time. Any delay on the part of the bidder/Indian Agent would be viewed seriously and he shall be directly responsible for any loss sustained by the purchaser on the event of the delay.

#### 2.17 Transportation

- 2.17.1 Where the Supplier is required under the Contract to deliver the Goods FOB, transport of the Goods, up to and including the point of putting the Goods on board the vessel at the specified port of loading, shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract price. Where the Supplier is required under the Contract to deliver the Goods FCA, transport of the Goods and delivery into the custody of the carrier at the place named by the Purchaser or other agreed point shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract Price.
- 2.17.2 Where the Supplier is required under the Contract to deliver the Goods CIF or CIP, transport of the Goods to the port of destination or such other named place of destination in the Purchaser's country, as shall be specified in the Contract, shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract Price.
- 2.17.3 In the case of supplies from within India, where the Supplier is required under the Contract to transport the Goods to a specified destination in India, defined as the Final Destination, transport to such destination, including insurance and storage, as specified in the Contract, shall be arranged by the Supplier, and the related costs shall be included in the Contract Price.
- 2.17.4 The clearing of the consignment at Bengaluru Airport shall be done by our authorized Custom House Agents (CHA) for CIP / CIF consignments. The details of CHA will be given in the Purchase

Order. The corresponding shipping documents may be forwarded to them accordingly. It is advised to give us and our CHA, a pre-alert before the consignment is dispatched. If there is delay in clearing of the consignment for not giving timely pre-alert then demurrage (Ware house charges) and/or penalty imposed by Indian Customs for late custom clearance, if payable has to be refunded to us by the Supplier / Indian Agent or the same will be deducted from any payment due to Supplier / Indian Agent against this order or any other Purchase order.

#### 2.18 Incidental Services

2.18.1 The supplier may be required to provide any or all of the services, including training, if any, specified in chapter 4.

#### 2.19 Spare Parts

2.19.1 The Supplier shall be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the Supplier:

	(a)	Such spare parts as the Purchaser may elect to purchase from the Supplier, providing that this election shall not relieve the Supplier of any warranty obligations under the Contract; and		
	(b)	In the event of termination of production of the spare parts:		
		(i)	Advance notification to the Purchaser of the pending termination, in sufficient time	
to permit the Purchaser to procure needed requirements; a			to permit the Purchaser to procure needed requirements; and	
		(ii)	Following such termination, furnishing at no cost to the Purchaser, the blueprints,	
L			drawings and specifications of the spare parts, if requested.	

## 2.20 Warranty

- 2.20.1 The Supplier warrants that all the Goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the Contract.
- 2.20.2 The Supplier further warrants that the Goods shall be free from defects arising from any act or omission of the Supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in India.
- 2.20.3 Unless otherwise specified in the SCC, the warranty shall remain valid for Twelve (12) months after the Goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the SCC, or for Eighteen (18) months after the date of shipment from the port or place of loading in the country of origin, whichever period concludes earlier.
- 2.20.4 The warranty on the associated software should cover providing of upgraded version/s, if any, released during the warranty period free of cost.
- 2.20.5 The bidder shall assure the supply of spare parts after warranty is over for maintenance of the equipment supplied if and when required for a period of 10 years from the date of supply of equipment on payment on approved price list basis.
- 2.20.6 The equipment must be supported by a Service Centre manned by the principal vendor's technical support engineers. The support through this Centre must be available 24 hours in a day, seven days a week and 365 days a year. Also it should be possible to contact the Principal's vendor support Centre on a toll free number/web/mail.
- 2.20.7 An undertaking from the manufacturer is required in this regard stating that they would facilitate the Bidder, Service provider on regular basis with technology / product updates & extend support for the warranty as well.
- 2.20.8 Supplier will have to arrange for all the testing equipment & tools required for installation, testing & maintenance etc.
- 2.20.9 The Principal Supplier must have a local logistics support by maintaining a local spares depot in the country of deployment of the equipment. This is to ensure immediate delivery of spares parts from Principal Supplier of equipment to its channel partner/system integrator.

- 2.20.10 Details of onsite warranty, Name of Agency that shall maintain during warranty and undertake Annual Maintenance Contract/Comprehensive Service Maintenance Contract beyond warranty shall be given in the offer. In case of foreign quote, the name of Indian Agent who shall maintain during warranty and AMC beyond warranty shall be given in the Technical Offer.
- 2.20.11 The Purchaser shall give notice to the Supplier stating the nature of any such defects together with all available evidence thereof, promptly following the discovery thereof. The Purchaser shall afford all reasonable opportunity for the Supplier to inspect such defects.
- 2.20.12 Upon receipt of such notice, the Supplier shall, within a reasonable period of time, expeditiously repair or replace the defective Goods or parts thereof, at no cost to the Purchaser.
- 2.20.13 If having been notified, the Supplier fails to remedy the defect within a reasonable period of time; the Purchaser may proceed to take within a reasonable period such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.
- 2.20.14 In case the Equipment / System remains non-operational or performs below the desired level for more than 1 week after intimation of the fault in the Equipment / System then Warranty period shall be extended for further period for which Equipment / System remained non-operational or performed below the desired level, without prejudice to any other terms and conditions of the Contract. The defects, if any, during the warranty period are to be rectified free of charge by arranging free replacement wherever necessary.
- 2.20.15 In case of any replacement during the warranty period the same shall be made free of cost i.e. DDP for import replacement and/or free delivery to CSIR-NAL for indigenous replacement. All the duties / taxes relating to these replacements have to be borne by the supplier. Dispatch details of such warranty replacements have to be informed in advance to enable us to provide documents for custom clearance.
- 2.20.16 Any replacements during warranty period should be free of cost. If the defective item has to be sent back to the Principal Supplier, for such replacements / returns to the Principal Supplier / Indian Agent has to bear documentation charges. If the cost of replacement is upto Rs.5 Lakh then the documentation charges will be Rs. 5,000/- and above Rs. 5 Lakh it is Rs. 10,000/-. Such charges have to be paid in favour of The Director, CSIR-NAL, Bengaluru. These charges are only for documentation. Any charges regarding packing, forwarding, freight, insurance, etc. should be borne by the Principal supplier / Indian Agent for returning of defective items. In other words, any warranty replacement has to be done immediately/within a week (7 days) without expecting CSIR-NAL to export the defective items to Principal supplier for repair/replacements. All charges involved for re-export of defective items have to be borne by Principal supplier / Indian Agent.

## 2.21 Terms of Payment

- 2.21.1 The method and conditions of payment to be made to the Supplier under this Contract shall be as specified in the SCC.
- 2.21.2 The Supplier's request(s) for payment shall be made to the Purchaser in writing, accompanied by an invoice describing, as appropriate, the Goods delivered and the Services performed, and by documents, submitted pursuant to Delivery and document Clause of the GCC and upon fulfilment of other obligations stipulated in the contract.
- 2.21.3 Payments shall be made promptly by the Purchaser but in no case later than thirty (30) days after submission of the invoice or claim by the Supplier. While claiming the payment, the supplier should certify in the bill/invoice that the payment being claimed strictly in terms of the contract and all obligations on the part of the supplier for claiming the payment have been fulfilled as required under the contract.

- 2.21.4 Kindly note, CSIR-NAL GST No.29AAATC2716R1ZB. Bidders are required to furnish their GST No. in the Invoice failing which, CSIR-NAL will not be able to make timely payment.
- 2.21.5 Payment shall be made in currency as indicated in the contract.
- 2.21.6 Advance payment will be paid in exceptional cases only against equivalent amount of Bank Guarantee or Stand by Letter of credit valid till acceptance of all ordered goods and services. Advance payment shall not exceed 30% of Purchase Order value.

#### 2.22 Change Orders and Contract Amendments

2.22.1 The Purchaser may at any time, by written order given to the Supplier pursuant to Clause on Notices of the GCC make changes within the general scope of the Contract in any one or more of the following:

(a)	Increase or decrease in the quantity required, exercise of quantity opinion clause;
(b)	Changes in schedule of deliveries and terms of delivery;
(c)	The changes in inspection arrangements;
(d)	Changes in terms of payments and statutory levies;
(e)	Changes due to any other situation not anticipated;

- 2.22.2 If any such change causes an increase or decrease in the cost of, or the time required for, the Supplier's performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or delivery schedule, or both, and the Contract shall accordingly be amended. Any claims by the Supplier for adjustment under this clause must be ascertained within fifteen (15) days from the date of the Supplier's receipt of the Purchaser's change order.
- 2.22.3 No variation or modification in the terms of the contract shall be made except by written amendment signed by the parties.

## 2.23 Assignment

2.23.1 The Supplier shall not assign, in whole or in part, its obligations to perform under the Contract, except with the Purchaser's prior written consent.

#### 2.24 Subcontracts

2.24.1 The Supplier shall notify the Purchaser in writing of all subcontracts awarded under this Contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the Supplier from any liability or duties or obligation under the contract.

#### 2.25 Extension of time.

- 2.25.1 Delivery of the Goods and performance of the Services shall be made by the Supplier in accordance with the time schedule specified by the Purchaser.
- 2.25.2 If at any time during performance of the Contract, the Supplier or its sub-contractor(s) should encounter conditions impeding timely delivery of the Goods and performance of Services, the Supplier shall promptly notify the Purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the Supplier's notice, the Purchaser shall evaluate the situation and may, at its discretion, extend the supplier's time for performance with or without liquidated damages, in which case the extension shall be ratified by the parties by amendment of the Contract.
- 2.25.3 Except as provided under the Force Majeure clause of the GCC, a delay by the Supplier in the performance of its delivery obligations shall render the Supplier liable to the imposition of liquidated damages pursuant to liquidated damages Clause of the GCC unless an extension of time is agreed upon pursuant to above clause without the application of penalty clause.

### 2.26 Penalty Clause / Liquidated Damages

2.26.1 Subject to GCC Clause on Force Majeure, if the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as penalty, a sum equivalent to the percentage specified in SCC of the delivered price of the delayed Goods or unperformed Services or contract value in case the delivered price of the delayed goods or

unperformed services cannot be ascertained from the contract, for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the Percentage specified in SCC. Once the maximum is reached, the Purchaser may consider termination of the Contract pursuant to GCC Clause on Termination for Default. The SCC shall also indicate the basis for ascertaining the value on which the penalty shall be applicable.

#### 2.27 <u>Termination for Default</u>

2.27.1 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Supplier, terminate the Contract in whole or part

	or detailed the dalphier, terrimitate and defined the mineral part
(a)	If the Supplier fails to deliver any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by the Purchaser pursuant to GCC
	Clause on Extension of Time; or

(c)	If the Supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent or

2.27.2 In the event the purchaser terminates the contract in whole or in part, he may take recourse to any one or more of the following action:

(a)	The Performance Security is to be forfeited;	
(b)	The purchaser may procure, upon such terms and in such manner as it deems	
	appropriate, stores similar to those undelivered, and the supplier shall be liable for all	
	available actions against it in terms of the contract.	
(c)	However, the supplier shall continue to perform the contract to the extent not terminated.	

#### 2.28 Force Majeure

- 2.28.1 Notwithstanding the provisions of GCC Clauses relating to extension of time, Liquidated damages and Termination for Default the Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- 2.28.2 For purposes of this Clause, "Force Majeure" means an event or situation beyond the control of the Supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- 2.28.3 If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof within 21 days of its occurrence. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 2.28.4 If the performance in whole or in part or any obligations under the contract is prevented or delayed by any reason of Force Majeure for a period exceeding 60 days, either party may at its option terminate the contract without any financial repercussions on either side.

#### 2.29 Termination for Insolvency

2.29.1 The Purchaser may at any time terminate the Contract by giving written notice to the Supplier, if the Supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the Purchaser.

#### 2.30 Termination for Convenience

2.30.1 The Purchaser, by written notice sent to the Supplier, may terminate the Contract, in whole or in part, at any time. The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.

- 2.30.2 The Goods that are complete and ready for shipment within 30 days after the Supplier's receipt of notice of termination shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect:
  - (a) To have any portion completed and delivered at the Contract terms and prices; and/or
  - (b) To cancel the remainder and pay to the Supplier an agreed amount for partially completed Goods and for materials and parts previously procured by the Supplier.

#### 2.31 Settlement of Disputes

- 2.31.1 The Purchaser and the supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
- 2.31.2 If, after twenty-one (21) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Purchaser or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract.
- 2.31.3 The dispute settlement mechanism/arbitration proceedings shall be concluded as under:
  - (a) If any dispute or difference arises between the parties hereto as to the construction, interpretation, effect and implication of any provision of this agreement including the rights or liabilities or any claim or demand of any party against other or in regard to any other matter under these presents but excluding any matters, decisions or determination of which is expressly provided for in this Agreement, such disputes or differences shall be referred to an Arbitral Bench consisting of three Arbitrators, one each to be appointed by each party and the two Arbitrators shall appoint a third Arbitrator who shall be the presiding Arbitrator. A reference to the Arbitration under this Clause shall be deemed to be submission within the meaning of the Arbitration and Conciliation Act, 1996 and the rules framed thereunder for the time being in force. Each party shall bear and pay its own cost of the arbitration proceedings unless the Arbitrators otherwise decides in the Award. The venue of arbitration should be the place from where the Contract has been issued.
  - (b) In the case of a dispute between the purchaser and a Foreign Supplier, the dispute shall be settled by arbitration in accordance with provision of sub-clause (a) above. But if this is not acceptable to the supplier then the dispute shall be settled in accordance with provisions of UNCITRAL (United Nations Commission on International Trade Law) Arbitration Rules.
- 2.31.4 The venue of the arbitration shall be the place from where the purchase order or contract is issued.
- 2.31.5 Notwithstanding, any reference to arbitration herein,
  - (a) The parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and
  - (b) the Purchaser shall pay the Supplier any monies due the Supplier.

#### 2.32 Governing Language

2.32.1 The contract shall be written in English language which shall govern its interpretation. All correspondence and other documents pertaining to the Contract, which are exchanged by the parties, shall be written in the English language only.

### 2.33 Applicable Law / Jurisdiction

2.33.1 The Contract shall be interpreted in accordance with the laws of the Union of India and all disputes shall be subject to place of jurisdiction as specified in SCC.

#### 2.34 Notices

2.34.1 Any notice given by one party to the other pursuant to this contract/order shall be sent to the other party in writing or by cable, telex, FAX, e-mail or and confirmed in writing to the other party's address specified in the SCC.

2.34.2 A notice shall be effective when delivered or on the notice's effective date, whichever is later.

#### 2.35 Taxes and Duties

- 2.35.1 For goods manufactured outside India, the Supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside India.
- 2.35.2 For goods Manufactured within India, the Supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred till its final manufacture/production.
- 2.35.3 If any tax exemptions, reductions, allowances or privileges may be available to the Supplier in India, the Purchaser shall make its best efforts to enable the Supplier to benefit from any such tax savings to the maximum allowable extent without any commitment.
- 2.35.4 a) All payments due under the contract shall be paid after deduction of statutory levies (at source) (like TDS, IT, TCS etc.) wherever applicable. In this connection Gol notification may be referred to before submitting quote on their own interest. Statutory deductions will be done accordingly at the time of payment.
  - b) If the supplier have not filed Income Tax Returns for the latest FY, TDS/TCS is applicable as per Income Tax Act.
  - Withholding Taxes are applicable on Foreign payments such as but not limited to Royalty, Fees for Technical Services etc..

#### 2.35.5 Customs Duty:

- a) If the supply is from abroad this Institute is permitted to import goods as per notification No.51/96 - Customs and pay a concessional duty up to 5% plus surcharges, if any as per notification 24/2002 - Customs on all imports.
- b) The Certificates is issued without any commitment by CSIR-NAL. Hence, the supplier should ensure its applicability for their own interest.

#### 2.35.6 **GST**

- (a) The Purchaser is registered with Dept. of Scientific & Industrial Research, Govt. of India and concessional customs duty and GST & IGST are leviable vide notification No. 54/2002-Customs on all imports covered under Notification No.51/96-Customs dated 23.07.1996, Notification No.47/2017-Integrated Tax (Rate) and Notification No. 45/2017-Central Tax (Rate) both dated 14th November, 2017.
- (b) The Certificates is issued without any commitment by CSIR-NAL. Hence, the supplier should ensure its applicability for their own interest.

### 2.36 Right to use Defective Goods

2.36.1 If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the Purchaser shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation.

#### 2.37 Protection against Damage

2.37.1 The system shall not be prone to damage during power failures and trip outs. The normal voltage and frequency conditions available at site as under:

(a)	Voltage 230 volts - Single phase/ 415 V 3 phase (+_ 10%)
(b)	Frequency 50 Hz.

#### 2.38 Site preparation and installation

2.38.1 The Purchaser is solely responsible for the construction of the equipment sites in compliance with the technical and environmental specifications defined by the Supplier. The Purchaser will designate the installation sites before the scheduled installation date to allow the Supplier to perform a site inspection to verify the appropriateness of the sites before the installation of the Equipment, if required. The supplier shall inform the purchaser about the site preparation, if any, needed for installation, of the goods at the purchaser's site immediately after notification of award/contract.

#### 2.39 Import and Export Licenses

- 2.39.1 If the ordered materials are covered under restricted category of EXIM policy in India the Bidder/ Agent may intimate such information for obtaining necessary, license in India.
- 2.39.2 If the ordered equipment is subject to Bidder procuring an export license from the designated government agency / country from where the goods are shipped / sold, the Vendor/Bidder has to mention the name, address of the government agency / authority. The Bidder must also mention the time period within which the license will be granted in normal course.

#### 2.40 Risk Purchase Clause

2.40.1 If the supplier fails to deliver the goods within the maximum delivery period specified in the contract or Purchase Order, the purchaser may procure, upon such terms and in such a manner as it deems appropriate, Goods or Services similar to those undelivered and the Supplier shall be liable to the purchaser for any excess costs incurred for such similar goods or services.

#### 2.41 Option Clause / Purchaser's right to vary quantities

2.41.1 The Purchaser reserves the right to increase or decrease the quantity of the required goods up to 25% (Twenty-Five) per cent at any time, till final delivery date (or the extended delivery date of the contract), by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of the delivery period (or the extended delivery period)

#### 2.42 Integrity Pact

- 2.42.1 As per directive of the CVC all organizations including CSIR laboratories / institutes have to adopt an Integrity pact (IP) to ensure transparency, equity and competitiveness in major Public procurement having procurement value above Rs.3 Crore. ## 2.43 Order Acceptance

## Chapter 4

# Specifications and Allied Technical Details for 'Supply, Installation and Commissioning of Automated Fiber Placement (AFP) System'

#### 4.1 End Use:

The AFP system is intended for CNC controlled fully automated layup of thermoplastics (dry tape), thermoset (prepreg tape) and dry fibers (tape) composite materials (both carbon and glass fibers) on specified mould surfaces in the required fiber orientation (0°, ±45°, 90°) or any other desired orientation. The AFP system should also possess the fiber steering capability on desired paths from multiple spools simultaneously.

#### 4.2 Detailed Specifications

### 4.2.1 System Envelope

**4.2.1.1** Machine design should be a Portal Gantry construction with floor level guideways design. **AFP** head mounted on a robotic arm will not be considered. Machine Axes configuration should consist of six axes namely three head position axes (linear axes) on gantry & three head orientation axes (rotational axes) on AFP head.

- **4.2.1.2** Portal guiding system assembly shall consist of two high precision rail lines hardened and grounded with special anti-corrosive surface finish for longer life.
- **4.2.1.3** X axis configuration should allow possibility to extend X axis stroke in future for additional length.

**4.2.1.4** All linear and rotary axes should work synchronously to achieve the desired accuracy of tape laying.

## 4.2.2 Mould Surface Configurations & Sizes

- **4.2.2.1** The AFP system should be capable of carrying out layup on tools made out of Aluminum alloy, Composite material, Cast Iron or Steel. Vendor/Bidder should specify the tooling requirements for AFP layup process like tool material and any extra length required from part boundary etc.
- **4.2.2.2** The machine should be able to carryout layup on moulds having surface roughness of Ra 1.6 to 6.3  $\mu$ m (two triangle finish- N7, N8, N9).
- **4.2.2.3** The machine configuration shall enable composite material layup on the following type of mould surfaces for the specified envelope:

## 4.2.3 MATERIALS TO BE LAID

**4.2.3.1** The machine should have the multi materials capability as follows viz., thermoplastics (dry tape), thermoset (prepreg tape) and dry fibers (tape) for both carbon and glass fibers. The AFP head should be capable of handling ply thicknesses range of 0.1mm to 0.3mm and aerial weight of material being laid up from 125 g/m2 to 300 g/m2. The machine shall enable continuous lay-up of the following materials in the specified forms on to the mould surfaces specified in section 4.2.2

## 4.2.4 Essential Requirements of the Fiber Placement System

- **4.2.4.1** Continuous lay-up from (i) 4 spools and (ii) any number of spools as defined bu user for the materials specified in Section 4.2.3
- **4.2.4.2** The ply material shall be placed on the mould surface in accordance with the part program, in the required fiber orientation (0°, ±45°, 90°) or any other desired orientation. The machine should also possess the fiber steering capability on desired paths.
- **4.2.4.3** Maintain alignment of tows to avoid twist & misplacement, overlap, wrinkles. gaps, overlaps, wrinkles, twist, missing tows, folds, bridging and splice etc.

**4.2.4.4** Accuracies of material placement (Nominal):

a) Linear position tolerance : +/- 0.10 mm/meter

b) Angular orientation tolerance : +/- 0.025°

c) Overlap of tapes : Not allowed/ not acceptable

d) Maximum gap between two adjacent :  $\leq 0.5 \text{ mm}$

e) Steering radius : 2500 mm or smaller radius

f) The global positioning accuracy at the : Shall not exceed 0.5 mm.

- **4.2.4.5** AFP head should have capability of IN-SITU consolidation of thermoplastic materials with set process parameters for the raw material specified in Section 4.2.3
- **4.2.4.6** Adjustable and programmable tension in prepreg tow. AFP head should be capable of maintaining the programmed tension tow while laying up.
- **4.2.4.7** Maintain alignment of tows to avoid twist & misplacement during layup. The process shall not introduce twist in the material from the spool/ creel to the lay-down point.
- **4.2.4.8** Automatic removal & spooling of protective paper/film on both sides or one side before lay-down point.
- **4.2.4.9** Precise & confined programmable pre-heating of tow near lay-down point to maintain required tackiness depending on the material being laid up. The temperature of heated material is to be displayed and recorded for quality control. The temperature requirements are defined in following section depending on the material being laid up.
- **4.2.4.10** Provision of Automatic cutting/ adding and restart of the individual tow to conform layup to the specified product boundary while ensuring minimum material wastage. The accuracy of length of tape laid on tool should be +/-0.5mm/m.
- **4.2.4.11** Maintain uniform compaction pressure on material laid up through conformable rollers. The compaction force shall be programmable based on the raw materials usage. The desired compaction force is defined in the following section.
- **4.2.4.12** The process shall not lead to detachment/ misalignment of the previously laid plies.
- **4.2.4.13** The spools/ creels shall be preferably located as close as possible to the lay-down point. The system shall detect the quantity of material available in each spool for layup and alert to be given to operator for spool change.
- **4.2.4.14** The elements of the fiber placement head shall be non-contaminating (no oil, grease, water, dust or any foreign object
- **4.2.4.15** The process shall not result in the removal of resin or breakage of the fiber from spool/ creel to lay-down point. Fiber breakage detection shall be enabled & the process to be stopped automatically in case of fiber breakage with suitable software interlock. The system shall allow re-start of the process from the last lay-down point after appropriate repair and/ or manual intervention.

- **4.2.4.16** Suitable software interlock should be incorporated to automatically stop the system in case of any abnormality like difference in (a) tension (b) temperature (c) compaction force with a proper feedback to operator on display system.
- **4.2.4.17** The system shall enable layup on Nomex honeycomb core parts (hexagonal cell or ox or flex-core). The core angle to horizontal plane will be in 10° to 20° range. The process shall not lead to crushing/ damage/ displacement of the honeycomb core.
- **4.2.4.18** The system shall perform layup having local layup thickness variation, ramps, layup around cutouts.

The mould on which the layup has to be done will be positioned with in the working volume of the machine. The mould will have reference pads for the machine to identify its location with the working volume of the machine.

## 4.2.5 Overall Machine Configuration & Structure

The configuration of the basic machine is specified in the following section.

Automated Fiber Placement (AFP) head, mounted on the ram of a gantry type machine with floor low bed guideways design.

- **4.2.5.1** The fiber placement machine shall be suitably sized, configured and designed to lay down 4 tows (1/4"X4 tows=Total 1 inch wide or 1/2"X4 tows=Total 2 inch wide) of the materials indicated in section 4.2.3, effectively & accurately onto the moulds as indicated in section 4.2.2 The design of the system shall result in effective execution of the functionalities listed in section 4.2.6 & 4.2.7. Vendor/Bidder should provide details.
- **4.2.5.2** The system shall have required number of CNC controlled interpolated axes as defined in section 4.2.1 to enable the layup on representative moulds listed in section 4.2.2. The controller should have the capability to configure enough number of axes required to carry out the functions specified in Section 4.2.6 & 4.2.7
- **4.2.5.3** The system structure shall be designed & sized by means of the latest technological tools available for static, thermal and dynamic loads, which will enable an efficient, stable and safe operation of the machine under all possible load conditions & under prescribed operating environments. Details to be provided.
- **4.2.5.4** Operating environment: CSIR-NAL will provide a clean room with 100000 class (ISO 8) standard for installation of AFP system (air-conditioned at 20 to 26°C temperature with Relative Humidity (RH) between 40 to 70%).
- **4.2.5.5** The system should be suitably configured & built to have kinematic characteristics, which ensure adequate access & approach all over the envelope of the part for accurately laying & compacting the material tows on to the parts as per the part program. The details of the machine kinematics with respect to the operations to be carried out on the mould configurations specified shall be provided.
- **4.2.5.6** The system structure should be suitably designed & built and made thermally stable to hold and support the fiber placement head while moving in all orientations for laying & compacting the ply materials on to the parts effectively & accurately. Vendor/Bidder should provide details.
- **4.2.5.7** All linear & rotary axes shall be provided with suitable drive and control mechanisms with position feedback & closed loop CNC control for high speed & fine positioning. Vendor/Bidder should provide details.
- **4.2.5.8** The linear axes traverses of the machine shall be on LM guide ways with adequate number of pads and shall be sized to ensure the requisite stiffness & strength. The rotary axes shall be guided by appropriate bearings and shall be through servo motors coupled with gear train. The lubrication system for the guide ways shall ensure that no contamination occurs on the part layup. The guide ways shall be provided with protective covers. Vendor/Bidder should provide details.

- **4.2.5.9** The linear axes drives shall be through servo motors coupled with ball lead screws & pre-loaded nut OR through rack & pinion system. The design of the drive elements shall ensure the requisite stiffness & strength and shall eliminate the backlash errors. The drive elements shall be provided with protective covers. Vendor/Bidder should provide details.
- **4.2.5.10** Direct position feedback for all moving axes shall be through linear scales and rotary encoder to ensure specified accuracy in the working volume.
- **4.2.5.11** If any hydraulic counterbalancing system is incorporated, provision should be available for recovery of oil drop for preventing part pollution.
- **4.2.5.12** The system structure should have adequate space for loading & unloading the spools/ creels manually. Details to be provided.
- **4.2.5.13** The system structure should have adequate access & space for loading & unloading the parts/moulds using an EOT crane.
- **4.2.5.14** System (hardware & software) for referencing of the mould with respect to the machine axis shall be provided. Details to be provided.
- **4.2.5.15** The entire machine shall be tropicalized for trouble free operation in the environmental conditions at Bangalore-India.

#### 4.2.6 Automated Fiber Placement (AFP) Head Characteristics

The AFP head shall have the following features:

- a) 4 tows/ slit tapes of 1/4" resulting in a total band width of 1" and 4 slit tapes of 1/2" resulting in a band width of 2".
- b) AFP Head should be designed for automated lay-up of thermoplastic, thermoset or dry fiber carbon/glass prepreg tapes.
- c) Separate servo-controlled actuators to be used for each single tow / slit tape for better dynamics and accuracy.
- d) The fiber lay-up head shall have requisite number of CNC controlled axes to facilitate the layup of tow and slit tape onto the mould surface.
- e) The machine should be able to start from where it is stopped either due to power failure or given intentional stop.
- f) The fiber layup head shall have the capability of independent unwinding, guiding, laying and cutting of the tows and slit tapes. The system shall cut/ clamp & restart any individual tow /slit tape, as required. Complete description of the AFP head outlining its characteristics & features shall be provided by the Vendor/Bidder in their technical offer.

## 4.2.7 AFP Head: Main Characteristics

The AFP head shall have the following main characteristics.

- a) Standard number of tows / slit tapes: 4 nos.
- b) Standard tow / slit tape width: 12.7 mm (1/2") or 6.35mm (1/4"). The tolerance of tape width is  $\pm 0.125$  mm.
- c) All tows and slit tapes to be individually guided & controlled from creel to lay-down point.
- d) Tape Laying speed: minimum 15 m/min on moderately curved / flat tools
- e) Cut/ Add capability up to 30 m/min.
- f) Heating devices:
  - i. Infra-Red device for Thermoset resin / Dry fiber material system
  - ii. Laser device for Thermoplastic resin system

Detail specifications of above materials are specified in section 4.2.3

- g) Two different guide paths for even and odd tows / slit tapes.
- h) Additional pneumatically actuated axis, if required, to ensure proper compaction of the tows / slit tapes.
- i) Compaction roller located at the bottom of head to ensure proper compaction of tows/ slit tapes. The compaction roller shall be flexible / conformable for proper adaptation to curved

- surfaces. The resin in the tow and slit tape shall not adhere to the compaction roller or to any other part / feature of the FPS head in the tow / slit tape path from creel to lay-down point.
- j) The creel shall preferably be mounted, together on the head to avoid the tow length variation between the creel and the head.
- k) Cut & add on the fly to eliminate stop/ start conditions during cut/ add of each individual tow.
- I) Dynamic pin-point heating system to provide required heat at the laydown point.

## 4.2.8 Tow Guiding System

- a) The tension of each tow and slit tape shall be maintained and controlled via CNC, allowing the tow and slit tape to unwind and rewind, if required and maintain tension by means of a suitable tensioning system. Vendor/Bidder should provide details. Tension range (Variable): up to 10 Newton ± 10% per tow
- b) Tow cutting method: guillotine knife system pneumatic knife.
- c) Cutting angle: 90°
- d) Minimum Course length: 125 mm or lesser
- e) Transmission roller to synchronize the tows and slit tapes to the placement speed to ensure the correct position of tows and slit tapes when restarting on the mould surface.

## 4.2.9 On-Line Compaction System

- a) In order to account for the actual deviations of the mould surface with respect to its theoretical programmed surface, the head shall be fitted with a floating compaction system. The system shall use pneumatic actuators in order to achieve floatability by accommodating out of nominal mould / mandrel surface, combined with a measuring system in order to feedback the CNC and control the head position in closed loop. This device shall absorb out of nominal mould / mandrel deviations of up to ± 5 mm. Details to be provided by Vendor/Bidder.
- b) Compaction roller located at the bottom of head to ensure proper compaction of the tows/ slit tapes. The compaction roller shall be flexible / conformable for proper adaptation to curved surfaces. The resin in the tow and slit tape shall not adhere to the compaction roller or to any other part / feature of the AFP head in the tow / slit tape path from creel to laydown point.
- c) Compaction force should be defined by Vendor/Bidder and should be continuously controlled and adjusted from main control system. Compaction force up to 1000 Newton with continuously control and adjustment capability. The Vendor/Bidder can offer a system with higher compaction force if needed, to allow for in-situ consolidation of thermoplastics materials specified in section 4.2.3
- d) The control system should have provision to program the magnitude of pressure and as well as capability for on line changes. The minimum compaction pressure should be more than 100N.
- e) The pressure control shall have accuracy of ±10%. The pressure value shall be displayed on the Control System Monitor. Pressure roller shall have self-adapting feature that will ensure that every fiber is compacted with constant conditions.
- f) Roller vertical self-alignment travel: ±10 mm (roller floating to compensate the tool errors).
- g) Vendor/Bidder should provide with machine at least four rollers for four tows of 1/2" width (two for thermoset and two for thermoplastics prepreg) and four rollers for four tows of 1/4" width (two for thermoset and two for thermoplastics prepreg). The offered rollers should be able to work with materials specified in section 4.2.3 and the corresponding temperature defined in section 4.2.10 & 4.2.11.
  - Vendor/Bidder should define the life of the roller when used in the conditions specified above.

# 4.2.10 Material Heating System for Thermoset Prepreg and Dry Fiber with Thermoset Binder: Infrared Heating

An infrared system shall be provided to increase the temperature of the material in a controlled fashion at any layup speed. The heat transmission shall be programmable according to the main parameters of the fiber placement process like lay-up speed, material in use, etc. Feedback of temperature to be provided. Details of infrared heating system to be provided by Vendor/Bidder.

- **4.2.10.1** Heating temperature range: 40-80°C. Heating Accuracy to be ± 5° C from the set temperature. Heating power at least 1.2KW.
- **4.2.10.2** The system should have capability to automatically stop the heating when the thermoset/dry fiber prepreg layup process is not in use or overheating of tape (the thermoplastic layup process is in operation).
- **4.2.10.3** The compaction surface temperature is to be measured by contactless sensor (pyrometer). The measured temperature is to be recorded in the quality control system. The alarm function should be provided to prevent overheating of the lay-up tape and compaction surface.
- **4.2.10.4** The Vendor/Bidder should specify the SOP (Standard Operating Procedure) for changing IR and Laser heating systems and specify the time required for changing one system to another.

# **4.2.11** Material Heating System for Thermoplastic Prepreg and Dry Fiber With Thermoplastic Binder: Laser Heating

The offered laser heating system should have the following capabilities.

- **4.2.11.1** IR Pyrometer for temperature measurement and fine closed loop laser power control.
- **4.2.11.2** Laser power: at least 3.0 KW
- 4.2.11.3 Compaction surface laser heating range: 220°C 500°C
- **4.2.11.4** Adjustable laser-radiation angle
- 4.2.11.5 Adjustable optic distance
- **4.2.11.6** Two set of laser optics are required in the scope of supply (one for the  $\frac{1}{4}$ " tows and another for the  $\frac{1}{2}$ " tows.
- **4.2.11.7** Cooling system for the compaction roller / AFP head
- **4.2.11.8** The Vendor/Bidder should plan the overall system layout, control rooms and any other specific requirements and design system safety to meet the regulatory requirements of high power laser system. The following will be in CSIR-NAL scope of work at the installation site. The Vendor/Bidder should provide safety interlocks and any other features and integrate them for a proper and safe functioning of the AFP system.

The following will be in CSIR NAL scope of work at the machine installation site.

- a) Protected layup area: The preparation of protected layup area. However, Vendor/Bidder should provide safety lock that will prevent laser operation and will stop machine if the operator leaves safety room/enters layup area.
- b) Working environment with clean room of 100000 class (ISO 8).
- c) Control room/enclosure for operator
- d) Room/enclosure for cooling unit
- **4.2.11.9** Thermal camera for quality control with image processing capability for automated detection of defects like gaps, overlaps, wrinkles, twist, missing tows, folds, bridging, splice and the like.
- **4.2.11.10** Switching time from infrared heating to laser heating and vice versa to be stated.

#### 4.2.12 Creel House

**4.2.12.1** The creel house should have a capacity for 4 spools. A transparent cabinet should be provided to store and feed the system with the required amount of prepreg/dry fiber/thermoplastic tape. The tension required to do steering trajectories (non-geodesic trajectories) should be a programmable bidirectional value. There shall be provision to adjust/ program the tension through the CNC panel/ part program.

**4.2.12.2** The temperature required inside the creel house shall be controlled to avoid resin build up and tow sticking problems.

#### **4.2.12.3** Standard Creel specifications shall be:

- a) Quick spool change.
- b) Brake system to stop the spools and to keep fibers under tension.
- c) Re-spooling unit for the backing film.
- d) Tension should be obtained with servo motor using diameter compensation. Tension should be programmable and continuously adjusted.
- e) The system shall stop (with audio-visual alarm) if fiber is broken, spool is empty or fiber has not been restarted for a new path.
- f) Each spool position should be equipped with diameter monitoring sensor with alarm function.
- g) Inside of the creel should be equipped with lights for better visual inspection and manipulation.
- h) Creel shall be placed on the head or close to head to minimize distortion of tow / slit tape.
- i) The quantity of material available in any spool at any point of time should be fed back to the system.
- j) Sensors to control whether the spools turn or not and whether the fiber tension just after the spool is not higher than a nominal value.
- k) The creel shall be cooled to the required lower temperature to facilitate easy layup.
- I) Spool change alert.
- m) Spool specification:

Inner diameter of spool core : 76 mm

Maximum core length : 280 mm

Spool max outer diameter : 200 mm

Maximum spool width : 250 mm

Maximum spool weight : 8 kg

Material of the spool : Cardboard core or Plastic

- n) The spool position is to be equipped with diameter monitoring sensor with alarm function to indicate the operator
- o) Every tow should have separate tow delivery & Guiding system
- p) The machine should stop if the following conditions occur:
  - Broken fiber;
  - Fiber is not restarted for the new course;
  - Empty spool;
  - Safety reason.

# 4.2.13 Empty Spool Extraction

Suitable means should be available to remove empty spool rollers. Details to be provided.

## 4.2.14 Process Monitoring Camera

AFP head should be equipped with cameras for monitoring and quality control recording, focused on the placement area. Vendor/Bidder should define Camera specification to meet the QC requirements.

## 4.2.15 Monitoring of the Working Area

Vendor/Bidder should provide 2 (two) dome type of network HDTV cameras for monitoring of the working area and that should be positioned in the Clean room/ workshop at CSIR-NAL. Vendor/Bidder should define Camera specification.

#### 4.2.16 Mould Alignment System

The purpose of this system is for the proper alignment of working tool (Mould) with the AFP machine to achieve the required layup accuracies on tool. Control system should be adjusted according to the actual mould position. System details should be provided by Vendor/Bidder.

These measurements shall enable the mould alignment and the beginning of the fiber placement process.

- **4.2.16.1** Location tooling way: Ball measuring probe.
- **4.2.16.2** Collected position date for reference points shall be recalculated and the result shall give coordinates of the actual position of the Tool (Mould).

#### 4.2.17 Anti-Collision System

Collision avoidance shall be performed by means of suitable simulation package. Details to be provided.

## 4.2.18 Wireless Remote Pendant Control

Vendor/Bidder should provide one wireless remote pendant control with features to select machine movements on all axes, start/stop; feed-rate up/down; jog axis +/- movement, emergency stop button.

## 4.2.19 Control System

- **4.2.19.1** The fiber placement machine shall have a latest Computer Numerical Control Siemens 840 DSL or Beckhoff TwinCAT latest version dedicated to axes control & fiber placement processing with user friendly software for system control, process control and human system interface control including networking to the systems at site. The control system shall fully & seamlessly integrate all the features / systems / operations of the machine so as to result in the final intended functionalities. Detailed specifications & features and order code/designation of the modules proposed for the controller shall be clearly listed in the quotation.
- **4.2.19.2** Quality control and data acquisition of main process parameters should be part of the supply.
- **4.2.19.3** The machine shall be equipped with an operator panel housing the Siemens/Beckhoff HMI interface unit & other machine control switches. This panel shall also house the necessary display screens to show the status of the current task via user friendly GUI. This panel shall be suitably located so as to offer maximum operator ergonomics, visibility and without hindering the loading / unloading of mould / mandrels.
- **4.2.19.4** Process control function for monitoring and controlling of the main AFP process parameters:
  - a) Compaction pressure control.
  - b) Heating temperature control.
  - c) Cut-Restart management.
  - d) Tow in-line monitoring.
  - e) Management of the process control warning and alarm signals.
  - f) Other AFP process functions.

## 4.2.20 Quality Control and Management System

- **4.2.20.1** Both hardware and software required for quality control and data acquisition of main process parameters should be part of the supply.
- 4.2.20.2 Data Acquisition and data management hardware & software should monitor the following data:
  - a) Operator data input
  - b) Product data sheet input
  - c) Raw material data input
  - d) Raw material consumption
  - e) Operation and process time
  - f) Ambient temperature
  - g) Ambient humidity
  - h) Process speed

- i) Heating power value
- j) Compaction pressure
- k) Tension monitoring
- I) Running program data
- m) History data for every manufactured part
- n) Bar code reading function (bar code reader should be included)
- o) Generation of the Quality Control Report in .pdf or other format acceptable for the customer.
- p) Error registration system with parameters: time and date, layer number, name of the control program, course (trajectory) and course number (trajectory) of laying.

#### 4.2.21 Software Features

- **4.2.21.1** Software solution for offline design of composite laminate, programming and simulation, including all required components, platform and add-ons necessary for the solution to work shall be provided.
- **4.2.21.2** The programming software shall provide an environment for design, analysis and manufacturing of composite structures. The software shall generate the fiber placement paths that will comprise each layer of the composite part. The software shall be capable of generating the fiber placement paths for composite material lay up on mould surfaces specified in Section 4.2.2
- **4.2.21.3** Post processing of the ply data to generate the part program, where the ply data can be imported in the form of CATIA file or any of the neutral file formats such as \*. iges, \*. step formats.
- **4.2.21.4** The software should have a provision for introducing error compensation for the entire working volume of the machine based on the standard calibration values. It should automatically correct the co-ordinates, based on the compensation values generated by laser Interferometer or suitable calibration equipment.
- **4.2.21.5** Verifier for simulation of the layup process. Full virtual simulation (animation) of the layup process as per the part program shall be simulated including 3D featuring of the machine (with actual configuration & kinematics), current ply being laid, Layup direction, collision detection, motion check, off part motion, feed-back of non-compliance like excessive steering, gaps, etc. User-friendly graphical user interface shall be provided. Collision avoidance detection shall be enabled.
- **4.2.21.6** Software features such as mimic, data logging, alarm logging, part program history etc., should be available
- **4.2.21.7** Uploading of the part program to system controller.
- **4.2.21.8** Software should have possibility to export laser projection system data.
- **4.2.21.9** The generated CNC program must have automatically corrected for job alignment with machine planes (Part Co-ordinate transformation to machine co-ordinate) and programmed error compensation. Thus the software generates the CNC program for each layer of the component.
- **4.2.21.10**The software should allow the operator to select parameters such as lay-up start point, tape width, tape laying speed etc., based on the user input data.
- **4.2.21.11** User friendly graphical user interface for the machine operation. The essential production data should be instantaneously displayed.
- **4.2.21.12**Vendor/Bidder shall provide at least two seat floating product lifetime license for the software with free upgrades during warranty period.
- **4.2.21.13** Vendor/Bidder shall provide detailed software specifications, features & control architecture in the quotation.
- **4.2.21.14** Vendor/Bidder shall provide lifetime license for the software. The upgrades during warranty period shall be free of charge. Vendor/Bidder shall provide detailed software specifications,

modules offered and their features, control architecture in the quotation. The offered software modules should address all the software requirements specified in this tender document.

### 4.2.22 Electrical Supply

Supply voltage available at site in CSIR-NAL: 230V±10%, 50Hz, 1-phase AC supply/ 415V±10%, 50Hz, 3-phase AC supply. The Vendor/Bidder shall design and manufacture all the electrical and electronic components and control equipment, etc. considering power fluctuations of up to 10%.

## 4.2.23 Electric / Electronic Equipment

#### 4.2.23.1 Electric Cabinets

The electric cabinets shall include the following main elements:

- a. Transformers and power supply conditioners / protection circuitry necessary for the controller.
- b. Electrical / electronic control elements for all peripheral / auxiliary systems.
- c. Protection mechanisms like fuses, circuit breakers, etc.
- d. Automatic main switch.
- e. Safety switches / emergency stops.
- f. Light inside the cabinet.
- g. Cabinet mounted AC units for cooling the cabinet interior.
- h. Filters to avoid dust.
- i. Rodent protection systems.
- j. Earthing systems.

Details to be provided by Vendor/Bidder.

#### 4.2.23.2 Electric Installation

All the wiring used to connect the different elements of the system shall be protected with conduits and provided on drag chains to avoid damage and twisting/stretching. The installation shall comply with all the applicable Indian/ International regulations.

## 4.2.24 Safety Features

## 4.2.24.1 Operator protection

- a) The system shall comply with the relevant International Safety Standards.
- b) Vendor/Bidder should provide the required enclosure of the working area at CSIR-NAL for complying with the relevant Safety Standards due to utilization of Laser. The opening/closing of the entry into enclosure should be integrated with the system hardware and/ or software for the safety actions.
- c) The modes of operation inside the different system safety areas shall comply with current safety regulations.
- d) Adequate lighting as per the standards in vogue shall be provided at all the zones of the machine.
- e) Emergency stops to be provided at appropriate locations on the machine considering all the possible operator activities.
- f) Limit switches active in all modes of operation;
- g) Compliance to EMC (electromagnetic compatibility) requirements.

#### 4.2.24.2 Protection to the equipment

The protection to various systems of AFP in case of fault/failure scenarios should be specified by Vendor/Bidder.

## 4.2.25 Diagnostics

The offered system shall have following diagnostic features.

- **4.2.25.1** Data shall be provided to notify the operator of system status information and to help maintenance personnel troubleshoot system problems.
- **4.2.25.2** Alarm Monitor: Current alarm information shall be displayed at the system. Specific CNC alarms shall be displayed through the CNC display screen. Specific and general CNC alarms shall be displayed through a display screen.

#### **4.2.25.3** Self-Diagnostics to check the following:

- a. Fault of feedback system
- b. Fault of position control unit
- C. Fault of servo system
- d. Overheat
- e. Fault of CPU
- f. Fault of ROM
- g. Fault of RAM
- h. Fault of data transfer between CRT/ MDI
- i. Fault of part program storage memory

Any other parameter required for Self-Diagnostics should be included in the supply.

#### 4.2.26 Utilities & Site Requirements

The supplier shall provide the indicative layout drawing of the machine, clearly mentioning the dimensions, the location of various peripheral devices & their sizes. The supplier shall provide the foundation requirements, drawings, electrical power, special earthing or other infrastructure requirements within one month from date of receipt of PO. CSIR-NAL will keep the installation site ready as per the details given by the Vendor/Bidder with regard to the following.

- a) Foundation and floor
- b) Electrical power supply
- c) Pneumatic air supply
- d) Air-conditioning
- e) UPS connection for computers/work stations
- f) LAN connection for online assistance

## 4.2.27 Painting

The colour and scheme of machine and its accessories as applicable should be finalized in consultation with CSIR-NAL.

#### 4.2.28 Accessories/Spare parts to be supplied along with machine

The following accessories to be provided apart from those in standard scope of supply with the AFP machine:

- a. Item wise list of consumables and spares with individual item prices and supplier details.
- b. Item wise list of spares supplied free of cost for warranty maintenance.
- c. One set of tools (wrenches, keys etc.) for assembly and maintenance to be supplied along with the system.
- d. Compaction roller for thermoplastic Composites 10 Nos each for  $\frac{1}{4}$ " and  $\frac{1}{2}$ " tow width for diameter 50 mm
- e. Compaction roller for Thermoset & dry fiber Composites -10 Nos each for  $\frac{1}{4}$ " and  $\frac{1}{2}$ " tow width for diameter of 30, 40, 50 & 60 mm)
- f. Spare cutting blades for the AFP head 10 sets (40 pieces)
- g. Spare IR heating system
- h. Set of delivery rollers for AFP head 10 sets each for thermoset/dry fiber (and thermoplastics
- i. Spool Core 25 Nos
- j. Creels 50 Nos

Vendor/Bidder shall provide recommended spares to maintain the machine for the ten years.

#### 4.3 Supply of items and Incidental Works:

Scope of Supply includes the following:

- (i) Supply of the equipment / system along with the accessories as per clause No.4.2
- (ii) Installation, Commissioning and Acceptance as per clause No.4.4.5
- (iii) Training as per clause no.4.5
- (iv) On site comprehensive Warranty as per clause No.4.6.
- (v) Delivery Schedule as per clause No.4.7.

#### 4.4 Inspection & Tests

#### 4.4.1 General

- 1. The Supplier shall at its own expense and at no cost to the Purchaser carry out all such tests and/or inspections of the Goods and Related Services as are specified here.
- 2. The inspections and tests may be conducted on the premises of the Supplier or its subcontractor(s), at the point of delivery and/or at the Goods final destination.
- 3. Whenever the Supplier is ready to carry out any such test and inspection, it shall give a reasonable advance notice, including the place and time, to the Purchaser. The Supplier shall obtain from any relevant third party or manufacturer any necessary permission or consent to enable the Purchaser or its designated representative to attend the test and/or inspection.
- **4.** Should any inspected or tested Goods fail to conform to the specifications, the Purchaser may reject the goods and the Supplier shall either replace the rejected Goods or make alterations necessary to meet specification requirements free of cost to the Purchaser.
- 5. The Purchaser's right to inspect, test and, where necessary, reject the Goods after the Goods' arrival at final destination shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the Purchaser or its representative prior to the Goods shipment.
- **6.** The Supplier shall provide the Purchaser with a report of the results of any such test and/or inspection.
- 7. With a view to ensure that claims on insurance companies, if any, are lodged in time, the bidders and /or the Indian agent, if any, shall be responsible for follow up with their principals for ascertaining the dispatch details and informing the same to the Purchaser and he shall also liaise with the Purchaser to ascertain the arrival of the consignment after customs clearance so that immediately thereafter in his presence the consignment could be opened and the insurance claim be lodged, if required, without any loss of time. Any delay on the part of the bidder/ Indian Agent would be viewed seriously and he shall be directly responsible for any loss sustained by the purchaser on the event of the delay.
- 8. Before the goods and equipment are taken over by the Purchaser, the Supplier shall supply operation and maintenance Manuals together with Drawings of the goods and equipment built. These shall be in such details as will enable the Purchase to operate, maintain, adjust and repair all parts of the works as stated in the specifications.
- **9.** The Manuals and Drawings shall be in English language.
- 10. Unless and otherwise agreed, the goods and equipment shall not be considered to be completed for the purposes of taking over until such Manuals and Drawing have been supplied to the Purchaser.
- 11. On successful completion of acceptability test, receipt of deliverables, etc. and after the Purchaser is satisfied with the working of the equipment, the acceptance certificate signed by the Supplier and the representative of the Purchaser will be issued. The date on which

such certificate is signed shall be deemed to be the date of successful commissioning of the equipment.

#### 4.4.2 Manufacturer's Inspection Certificate

After the goods are manufactured and assembled, inspection and testing of the goods shall be carried out at the supplier's plant by the supplier, prior to shipment to check whether the goods are in conformity with the technical specifications. Manufacturer's test certificate with data sheet shall be issued to this effect and submitted along with the delivery documents. The purchaser reserves the options to be present at the supplier's premises during such inspection and testing. The pre-dispatch inspection will be done by CSIR-NAL and details are shown in Section 4.4.3

#### 4.4.3 Pre-Dispatch Inspection

CSIR-NAL will bear all the expenses of travel, accommodation, local hospitality for pre-dispatch inspection at manufacturer's site. Vendor/Bidder should not add any additional cost towards above expenses in the quote

#### 4.4.3.1 Pre-dispatch Acceptance Test Plan

- a) The positioning accuracy and positioning repeatability for all axes
- b) Layup test by laying two standard test parts (flat and curved) to check quality of laying, cutting, compaction and positioning of layup boundaries. The layup to be demonstrated for thermoplastic, thermoset and dry fiber materials.
- **C)** Generation of fiber placement paths and post processing of the ply data to generate the part program
- d) Inspection and acceptance of each layer for the placement accuracies.
- e) Any other tests outlined by the Vendor/Bidder in the quotation.

- (i) Equipment/ inspection tool/any other accessories required
- (ii) Composite raw material (thermoset tape, dry fiber and thermoplastic tape). The specifications of material can be mutually agreed between CSIR-NAL and Vendor/Bidder well before pre-dispatch inspection to enable Vendor/Bidder to arrange for the same.
- (iii) Layup tools for materials defined above.
- (iv) CAD model/data for layup.

#### 4.4.5 Installation, Commissioning and Acceptance Test

- **4.4.5.1** The system should be installed and commissioned by the Vendor/Bidder at CSIR-NAL by trained and experienced service engineers in the presence of CSIR-NAL personnel. The Vendor/Bidder shall install each of the sub-systems as per scope of supply (Guide ways, Portal frames, AFP control unit, AFP head, required computers/ workstations with necessary softwares, safety interlocks etc.), integrate them and successfully demonstrate satisfactory performance of all the sub-systems and the system as a whole.
- 4.4.5.2 The acceptance test will be conducted by CSIR-NAL, their consultant or other such person nominated by the CSIR-NAL at its option after the equipment is installed at CSIR-NAL's site in the presence of Vendor/Bidder's representatives. The acceptance will involve trouble free operation. There shall not be any additional charges for carrying out acceptance test. No malfunction, partial or complete failure of any part of the equipment is expected to occur. The Vendor/Bidder shall maintain necessary log in respect of results of the test to establish to the entire satisfaction of the CSIR-NAL, the successful completion of tests specified.
- **4.4.5.3** In the event of the ordered item failing to pass the acceptance test, a period not exceeding two weeks will be given to rectify the defects and clear the acceptance test, failing which, the CSIR-NAL reserves the right to get the equipment replaced by the Vendor/Bidder at no extra cost to the CSIR NAL.
- **4.4.5.4** Successful conduct and conclusion of the acceptance test for the installed system and equipment shall also be the responsibility and at the cost of the Vendor/Bidder.

Following acceptance tests will be performed at CSIR-NAL.

### Acceptance Tests at CSIR-NAL

- 1 a) Item wise inventory
  - b) Shake down or Composite Axes movement test (CAMT): This test is meant for assessing the reliability of the machine for continuous operation for a minimum period of 24 hours. For this purpose, all the axes will be operated simultaneously at 70 to 80% of their maximum speeds continuously for 24 hours. No failures of any system should occur during this test and temperature of various motors/ bearing will be monitored during this test.
  - c) Vendor/Bidder to demonstrate overall features of AFP system, other associated machinery, controller and software as per tender document.
  - d) All calibration to be completed and demonstrated by Vendor/Bidder
  - e) Geometrical tests to check the specified travels & accuracies.
  - f) Laser interferometer test to check positioning accuracy and repeatability for all axes.
  - g) Demonstration of capabilities of software including safety interlocks
  - h) Generation of fiber placement paths and post processing of the ply data to generate the part program.

## 2 | Acceptance Test Plan:

- a) Layup test by laying a standard test part to check quality of laying, cutting, compaction and positioning of layup boundaries. Raw materials and moulds will be provided by CSIR-NAL.
- b) Laying up of mutually agreed parts for the thermoset & dry fiber and for thermoplastic composites. Few representative tools are shown in section 4.2.2.
- c) Different thicknesses with different orientation will be laid up on specified tools.
- d) Layup of different profiles to realize steering capability of the machine.
- e) Inspection and acceptance of each layer for compliance to the material placement accuracies.

# CHAPTER-6 Qualification Requirements Eligibility & Qualification Requirements

#### 6.1 Eligibility Criteria

#### a) Legal Valid Entity:

The Bidder shall necessarily be a legally valid entity either in the form of a Limited Company or a Private Limited Company registered under the Indian Companies Act, 1956 or Country of Origin.

Bidder may be Joint Venture, Consortium or Association so long as they are formed and registered prior to the bid submission date.

Copy of Certificate of Incorporation issued by Registrar of firms/companies is to be submitted in support of this criterion.

- b) Only Class-I and Class-II local suppliers are eligible to participate in Domestic tender enquiry. Submit **Chapter-8:Annexure-I & J** with your bid/offer.
- c) In case of Global Tender Enquiry, Indian Agent quoting on behalf of Foreign Principal Supplier should submit a certified copy of an Agreement/Memorandum of understanding (MOU) between both the parties, detailing services to be rendered by the Agency.
- d) An undertaking (self-certificate) is to be submitted to demonstrate that the bidder satisfies the bidders' eligibility criteria, as mentioned in ITB Clause 1.1.2 in the form of declaration by the Bidder for Code of Integrity & conflict of interest as per <a href="#">Chapter-8:Annexure-L</a>.

#### 6.2 Technical Qualification Criteria

- a) The Bidder should be a manufacturer /authorized representative of a manufacturer who must have designed, manufactured, tested and supplied the equipment(s) similar to the type specified in the "Technical Specification". Authorised representative / Indian Agent to submit the Manufacturers' Authorization Form Chapter-8: Annexure E with the technical bid.
- b) 'The bidder' should have manufactured and supplied (/erected/commissioned) at least <u>01</u> numbers (herein after referred as 'The Qualifying Quantity') of 'The Product' in the last three years ending on 'The relevant Date', and out of which
  - i) At least <u>01</u> number of offered version/model of 'The product' should be in successful operation for at least <u>01</u> year on the date of bid opening.
- c) Equipment / System offered must be of the most recent series/models incorporating the latest improvements in design. The models should be in successful operation for at least <u>01</u> year as on date of Technical Bid Opening. The bidder (OEM/Direct Distributor/Dealer) should have supplied and installed during past <u>03</u> years, <u>at least one similar equipment / systems</u> as mentioned in Chapter-4.
- d) 'The bidder' must have an annual capacity to manufacture and supply (/erected/commissioned) at least <u>02</u> (The Qualifying Quantity)
- e) The Bidder should furnish the information on all past supplies and satisfactory performance during past <u>01</u> year in the Performance Statement Form (**Chapter-8: Annexure-F**). Bidders shall invariably furnish documentary evidence (Client's certificate) in support of the satisfactory operation of the equipment / system.
- f) Details of Service Centres and information on service support facilities that would be provided after the warranty period (in the **Service Support Form-Chapter-8 Annexure-G**).
- g) Foreign bidder/suppliers quoting directly, should submit a letter of Authorisation in favour of Indian Agent/Representative indicating complete address, contact person and validity of Authorization if any along with their technical bid. Foreign bidder/suppliers quoting directly should ensure that adequate and specialized expertise is already available or will be made

available following the execution of the contract in the Purchaser's country, to ensure that the support services are responsive and adequate as per ITB 1.14.2(c).

#### 6.3 Financial Qualification Criteria

- a) The average annual financial turnover of 'The bidder' during the last three years, ending on 'The relevant Date', should be at ₹30 Crore as per the annual report (audited balance sheet and profit & loss account) of the relevant period.
- b) A copy of the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries, is to be submitted in support of this criterion.

Ministry of MSME have clarified that all Central Ministries/Departments/Central Public Section Undertakings may relax condition of prior turnover and prior experience with respect to Micro and Small Enterprises in all public procurements subject to meeting of quality and technical specifications. Further, the condition of prior turnover and prior experience may be relaxed for Start-ups (as defined by Department of Industrial Policy and Promotion) subject to meeting of quality & technical specifications and making suitable provisions in the bidding document (rule 173 (i) of GFR 2017))

c) The net worth of the Bidder firm (manufacturer or principal of authorized representative) should not be negative on 'The Relevant Date' and also ii) should have not eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'.

Note: In case of Indian Bidders/companies (manufacturer or principal of authorized representative) who have been restructured by Banks in India, under the statutory guidelines, they would be deemed to have qualified the Financial standing criteria considering the institutional financial backing available to them.

#### Applicability in Special Cases:

#### a) Applicability to 'Make in India':

Bidders (manufacturer or principal of authorised representative) who have a valid/approved ongoing 'Make in India' agreement/ program and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided:

- i) their foreign 'Make-in-India' associates meet all the criteria above without exemption, and
- ii) the Bidder submits appropriate documentary proof for a valid/approved ongoing 'Make in India' agreement/program.
- the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

#### b) Authorized Representatives:

Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided:

- i) their principal manufacturer meets all the criteria above without exemption, and
   ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
- the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.

#### c) Joint Ventures and Holding Companies:

Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the

Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

#### **Note for Bidders:**

### a) 'Doctrine of Substantial Compliance':

The Pre-Qualification Bidding (PQB) and Pre- Qualification Criteria (PQC) are for shortlisting of sources who are competent to perform this contract to ensure best value for money from expenditure of Public Money. This process is neither intended to bestow any entitlement upon nor to create any rights or privileges for the Bidders, by way of overly hair-splitting or viciously legalistic interpretations of these criteria, disregarding the very rationale of the PQB and PQC. Keeping this caveat in view, interpretation by the Purchaser would be based on common usage of terminologies and phrases in public procurement in accordance with the 'Doctrine of Substantial Compliance' and would be final.

- b) The Bidder must declare, whether asked or not in a bid document, any previous transgressions of such a code of integrity with any entity in any country during the last three years or of being debarred by any other Procuring Entity. Failure to do so would amount to violation of this code of integrity.
- c) In case of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/ dealer. There can be only one bid from the following:
  - i) The Principal manufacturer directly or through one Indian agent on his behalf; andii) Indian/foreign agent on behalf of only one principal.

Original Documents must be submitted for inspection, if so demanded.
  - ii) All financial standing data should be certified by certified accountants, for example, Chartered Accountants/Cost Accountants or equivalent in relevant countries; and Indian bidder or Indian counterparts of foreign bidders should furnish their Permanent Account Number.
- f) A bidder or any of its affiliates who participated as a consultant in the preparation of the design or technical specifications of the contract i.e. the subject of the bid; cannot participate in the bidding process.

- (1) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

Further details as mentioned in the "Guidelines on Indian Agents of Foreign Suppliers" shall be disclosed by the Bidder(s)/Contractor(s). Further, as mentioned in the Guidelines all the payments made to the Indian agent/representative have to be in Indian Rupees only. - (e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (3) The person signing IP shall not approach the courts while representing the matters to IEMs and he/she will await their decision in the matter.

# Section 3 - Disqualification from tender process and exclusion from future Contracts

- (2) The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the JS (A), CSIR.
- The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/Contractor(s) / Subcontractor(s) with confidentiality.
- (4) The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- (5) As soon as the Monitor notice, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.
- (6) The Monitor will submit a written report to the JS(A), CSIR within 8 to 10 weeks from the date of reference or intimation to him by the Principal and should the occasion arise, submit proposals for correcting problematic situations.
- (7) Monitor shall be entitled to compensation on the same terms as being extended to/provided to Independent Directors on the CSIR.
- (8) If the Monitor has reported to the JS(A), CSIR, a substantiated suspicion of an offence under relevant IPC/PC Act, and the JS(A), CSIR has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- (9) The word 'Monitor' would include both singular and plural.

# Section 9 - Pact Duration

This Pact begins when both parties have legally singed it. It expires for the Contractor 10 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by JS(A), CSIR.

#### 1. Disclosure of Confidential Information

For the purpose of this agreement, "CSIR-NAL" is "Disclosing Party" and "XYZ" is "Receiving party" Under this agreement, CSIR-NAL may disclose confidential information to the Receiving Party either orally or in any recorded medium, during discussions and pre-bid meetings for providing information comprising or relating to: techniques, schematics, designs, contracts, financial information, sales and marketing plans, business plans, clients, client data, business affairs, operations, strategies, inventions, methodologies, technologies, employees, subcontractors, pricing, service proposals, methods of operations, procedures, products and/or services ("Confidential Information") related to SARAS Mk-II Aircraft programme. Receiving party shall certify in writing that it and its Representatives have returned all such information to Disclosing Party.

# 6. General

- a) This Agreement and all questions relating to its validity, interpretation, performance and enforcement (including, without limitation, provisions concerning limitations of actions), shall be governed by and construed in accordance with the laws of India and is subject to the exclusive jurisdiction of the Courts of Bangalore, India and may be modified only in writing and signed as accepted by both the Parties.
- b) Receiving Party agrees that the breach of the provisions of this Agreement by it, will cause Disclosing Party irreparable damage for which recovery of money damages would be inadequate. Disclosing Party will, therefore, be entitled to obtain timely injunctive relief to protect its rights under this Agreement in addition to any and all remedies available at law or in equity. Any Dispute or claim arising out of or relating to this Agreement shall be first tried to

solve through mutual discussions by authorized representatives of both the Parties. If no conclusion is arrived at through such mutual discussions within a period of 30 days, then the dispute should be settled by arbitration in accordance with Delhi International Arbitration Center (DIAC), Delhi High Court, New Delhi. Decision of arbitral tribunal shall be final and binding on the Parties. Parties shall equally bear the cost of arbitration and its proceedings unless the award provides otherwise.
