- Termination of Service: The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 30 days. In case, a part time medical officer desires to leave the contract/job, he/she has to serve the notice period of one month which can be curtailed/extended at the discretion of the Competent Authority
- 3. The date for determining age/qualification and experience shall be the date of the walk in interview
- 4. No TA/DA will be paid to the candidates for attending the walk-in interview or for joining, if selected.
