**Specifications for Data Loss Prevention (DLP) features**

- Shall capture logs of Data Exchange activity on Organization Information Asset done through any medium like email, internet upload, USB transfer etc.
- Shall be able to monitor data events in real-time and enforce security policies that are managed centrally.
- Shall be possible to block all channels through which potential data loss can take place, including, but are not restricted to, removable drives, network sharing, screen capture, clipboard, web-based apps, cloud storage services and email attachments.
- Shall be possible to identify Office documents based on their origin, or based on rules for preventing sensitive information from getting copied via web apps or other sharing technologies.
- Shall provide regular and timely user notifications to reinforce preset security compliance policies and to adjust user behavior as per the protocols in place.
- Shall have a Centralized management console for enforcing security policies across entire network and offsite locations systems connected through VPN and enabling sensitive data visibility across the network.
- Shall provide detailed security reports and audits via centralized management console.
- Shall provide event monitoring in real-time on the centralized management console for incident management
- Shall provide interface for collecting statistics about data access and other reports
- Shall be a client server architecture with centralized management console
- Shall have the feature of managing clients with pushing of updates, group and policies through central management console with email notifications and easy deployment
- Shall have Real-time Scanning for Local Files and Network Shares during Read & Write operation
- Shall have antivirus and anti ransomware protection
- Shall have application controls for prevention of unauthorized applications
