1.1 General

Fatigue resistant load cell is required to accurately sense load and provide a precise electrical output signal, which is proportional to the load applied. Four arm strain gauge bridges should be used as sensing devices with dual bridge. The load cells should be suitable for mounting directly on actuators piston rod and suitable for tension, compression and fatigue loading. The technical specification of the required load cell is given below.
