Specifications for Proving Rings

- 1. Total No. of proving rings required: 7 Nos.
- 2. Capacity of proving ring:
- a) Tension and compression type 0.5kN, 5kN, 20kN, 50kN, 100kN each one number
- b) Compression type 200kN, 2000 kN each one number.
- 3. Construction: Ring type, Single piece forged construction. Integral type proving ring with the loading (outside) bosses are forged integral with the ring body.
- 4. Material: Corrosion resistant body and made of steel/steel alloy.
- 5. Loading arrangement: Necessary self-aligning compression pads and tension shackles must be provided. The End of tension shackle may have a flat or threated end.
- 6. Proving ring deflection range at maximum load capacity: 0.84 mm to 4.24 mm.
- 7. Deflection measurement: High accurate Mechanical dial type analogue gauge precisely aligned and integrated with the proving ring must be provided. The ratio of width of the pointer to centre- centre distance between two graduation marks must be 1:10. The spacing of dial graduation must be greater than 1.25mm.
- 8. Calibration: Each proving ring must be calibrated at NPL, Delhi and the original certificate of the same must be supplied along with each proving ring. Calibration certificate must contain the requirements to prove the compliance of IS 4169-2014. The proving rings must comply to class-2 or higher requirements as per IS 4169-2014. Calibration certificate must contain zero force reading after end of calibration or percentage of creep error has to be noted. Uncertainty of measurement for each proving ring must be evaluated and provided in the calibration certificate.
- Proving rings must fulfil all the requirements of Indian Standard IS 4169-2014.
- 10. Overload: Proving Rings must meet the overload capacity requirements specified in IS 4169-2014.
- 11. Proving Rings without valid calibration and proof of compliance to IS 4169-2014 products will be rejected.
- 12. Casing: proving ring must be supplied in a polished wooden enclosure with proper cushion and locking arrangement for easy transport

NOTE: Copy of previous purchase orders or sales data of the same equipment to Aerospace Industries/R&D Institutes such as ISRO, DRDO or any other CSIR labs purchased preferably in the last 3 years shall be provided.
