Specifications for Knee Type Milling Machine

- The milling machine must be designed to withstand shocks and vibrations induced while
 machining high strength materials for aerospace applications. Change of spindle speed
 should be achieved by shifting/rotating the gear lever of the machine. The main spindle
 should have Instantaneous braking mechanism.
- The table on which job/material is mounted should have necessary clamping provisions.
 The table should have auto feed and high rate rapid operations in all X, Y, Z directions by independent electrical motor.
- The machine must supplied with necessary service/maintenance manual, service/spare tools, and must provide service/maintenance and spare support for atleast 10 years from the date of delivery.
- The specification of machine should confirm to IS 6893 part 5-latest.
- Accuracy test for inspection of the machine should confirm to IS 2200-latest.
