### 1. Solar charge controller

Charge controller section will be tested by providing DC supply from regulated power supply and output will be observed for specified rating as given below

Maximum power of 1.2kW, operating DC voltage of 35-60V, no load voltage of 80V DC and input current of 25A.

# 2. Generator charge controller

Generator charge controller section will be tested by providing 3 phase supply given from generator and output will be observed for specified rating as given below

Maximum power of 1.2kW, operating DC voltage of 24-40V, no load voltage of 60V AC and input current of 30A.

# 3. Battery charging section

Battery charging section will be connected to 200Ah, 24V battery. The charging and discharging voltage and current will be monitored.

#### 4. Inverter section

Battery and gird will be connected then the output of inverter section will be monitored for single phase 230V AC, 50Hz for no load and 2kw load.
